## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411R. (1) EXCEPT AS PROVIDED IN SUBSECTION (2), A
- 2 PERSON SHALL NOT DIRECT A LASER LIGHT BEAM FROM A LASER LIGHTING
- 3 DEVICE AGAINST ANOTHER PERSON WITH THE INTENT TO HARASS, ANNOY,
- 4 OR ALARM THAT OTHER PERSON. A PERSON WHO VIOLATES THIS SUBSEC-
- 5 TION IS GUILTY OF A MISDEMEANOR, PUNISHABLE BY IMPRISONMENT FOR
- 6 NOT MORE THAN 90 DAYS OR A FINE OF NOT MORE THAN \$100.00, OR
- **7** BOTH.
- 8 (2) A PERSON SHALL NOT INTENTIONALLY DIRECT A LASER LIGHT
- 9 BEAM FROM A LASER LIGHTING DEVICE AGAINST AN ON-DUTY UNIFORMED
- 10 LOCAL, STATE, OR FEDERAL LAW ENFORCEMENT OFFICER, OR AGAINST AN
- 11 ON-DUTY NONUNIFORMED LOCAL, STATE, OR FEDERAL LAW ENFORCEMENT
