

**SENATE BILL NO. 735**

September 23, 1999, Introduced by Senators MC COTTER, JOHNSON, HAMMERSTROM, ROGERS, SCHUETTE, EMMONS, MC MANUS, GOSCHKA, STILLE, BENNETT, GAST, SHUGARS, GOUGEON, BULLARD, SIKKEMA, NORTH, STEIL, DINGELL, PETERS, EMERSON, HART, MURPHY, BYRUM, KOIVISTO, DE BEAUSSAERT, MILLER, CHERRY, A. SMITH, YOUNG, V. SMITH and LELAND and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled  
"The Michigan penal code,"  
(MCL 750.1 to 750.568) by adding section 411r.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1        SEC. 411R. (1) A PERSON SHALL NOT, WHILE ON SCHOOL PROPER-  
2 TY, THREATEN TO KILL OR INJURE ANY PERSON OR THREATEN TO DAMAGE  
3 OR DESTROY ANY REAL OR PERSONAL PROPERTY.

4        (2) AN INDIVIDUAL WHO VIOLATES THIS SECTION IS GUILTY OF A  
5 FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1 YEAR AND 1  
6 DAY OR A FINE OF NOT MORE THAN \$500.00, OR BOTH.

7        (3) THIS SECTION DOES NOT PROHIBIT A PERSON FROM BEING CON-  
8 VICTED OF OR SENTENCED FOR ANY OTHER VIOLATION OF LAW ARISING OUT  
9 OF THE SAME TRANSACTION AS THE VIOLATION OF THIS SECTION.

10       (4) AS USED IN THIS SECTION:



1 (A) "SCHOOL" MEANS ANY OF THE FOLLOWING:

2 (i) A PUBLIC, PRIVATE, DENOMINATIONAL, OR PAROCHIAL SCHOOL  
 3 OFFERING DEVELOPMENTAL KINDERGARTEN, KINDERGARTEN, OR ANY GRADE  
 4 FROM 1 THROUGH 12.

5 (ii) A JUNIOR COLLEGE, COLLEGE, OR UNIVERSITY.

6 (B) "SCHOOL PROPERTY" MEANS A BUILDING, PLAYING FIELD, OR  
 7 PROPERTY USED TO IMPART INSTRUCTION TO STUDENTS ATTENDING THAT  
 8 SCHOOL OR USED FOR FUNCTIONS AND EVENTS SPONSORED BY THAT SCHOOL.
