A bill to amend 1941 PA 207, entitled
"Fire prevention code,"
by amending section 6 (MCL 29.6).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 6. (1) The state fire marshal may investigate and
2 inquire into the cause or origin of a fire occurring in this
3 state resulting in THE loss of life or damage to property ~~—~~ and
4 for ~~that purpose~~ THOSE PURPOSES may enter, without restraint or
5 liability for trespass, a building or premises and inspect the
6 building or premises and the contents and occupancies of the
7 building or premises.

8 (2) THE STATE FIRE MARSHAL SHALL INVESTIGATE, AND PREPARE A
9 REPORT OF THE INVESTIGATION, IF A DEMONSTRATION FIRE RESULTS IN
10 THE INJURY OR DEATH OF AN INDIVIDUAL WHO IS NOT A FIREFIGHTER.
11 AS USED IN THIS SUBSECTION, "DEMONSTRATION FIRE" MEANS A FIRE

1 INTENTIONALLY SET BY A FIRE DEPARTMENT FOR TRAINING OR OTHER
2 LEGITIMATE PURPOSES.

3 (3) THE CHIEF OF A FIRE DEPARTMENT SHALL IMMEDIATELY REPORT
4 TO THE STATE FIRE MARSHAL ANY INJURY TO OR DEATH OF A PERSON WHO
5 IS NOT A FIREFIGHTER RESULTING FROM A DEMONSTRATION FIRE.

6 (4) IF A FIREFIGHTER DIES OR SUFFERS A REPORTABLE INJURY AS
7 DEFINED UNDER THE MICHIGAN OCCUPATIONAL SAFETY AND HEALTH ACT,
8 1974 PA 154, MCL 408.1001 TO 408.1094, RESULTING FROM A DEMON-
9 STRATION FIRE, THE DEPARTMENT OF CONSUMER AND INDUSTRY SERVICES
10 SHALL PROVIDE A COPY OF ANY REPORT OF THE DEATH OR REPORTABLE
11 INJURY TO THE STATE FIRE MARSHAL.

12 (5) AS USED IN THIS SECTION, "INJURY" MEANS AN INJURY THAT
13 REQUIRES PROMPT MEDICAL ATTENTION BY TRAINED MEDICAL PERSONNEL.
