- 4 UNDER SECTION 32912. THE REPORT SHALL DETAIL THE SPECIFICS OF
- 5 THE PILOT PROGRAM AND SHALL ASSESS THE SUCCESS OF THE ON-BOARD
- 6 BALLAST WATER MANAGEMENT SYSTEM IN PREVENTING THE INTRODUCTION
- 7 AND SPREAD OF AQUATIC NUISANCE SPECIES IN THE GREAT LAKES.
