- 2 LISH A PILOT PROGRAM FOR AN ON-BOARD BALLAST WATER MANAGEMENT
- 3 SYSTEM THAT WILL PREVENT THE INTRODUCTION AND SPREAD OF AQUATIC
- 4 NUISANCE SPECIES WITHIN THE GREAT LAKES. THE ON-BOARD BALLAST
- 5 WATER MANAGEMENT SYSTEM SHALL BE DESIGNED TO STERILIZE AND MONI-
- 6 TOR BALLAST WATER AND SEDIMENTS CARRIED ON A VESSEL. BALLAST
- 7 WATER AND SEDIMENTS SHALL BE STERILIZED IN A MANNER PRESCRIBED BY
- 8 THE OFFICE OF THE GREAT LAKES AND MONITORED ELECTRONICALLY BY THE
- 9 OFFICE VIA SATELLITE TRANSMISSION.
