- 5 assigns the owner's title or interest to the mobile home, the

- 9 not been paid and the fee is not paid upon reasonable notice or

- 13 (e) Upon receipt of notification from another state or for-
- 14 eign country that a certificate of title issued by the department
- 15 has been surrendered by the owner in conformity with the laws of

- 17 (i) NAME AND ADDRESS OF THE SELLER OR TRANSFEROR.
- 18 (ii) NAME AND ADDRESS OF THE BUYER OR TRANSFEREE.
- 19 (iii) DESCRIPTION OF THE MOBILE HOME CONTAINED IN THE CER-
- 20 TIFICATE OF TITLE.
- 21 (iv) VALUE OF THE MOBILE HOME BEING TRANSFERRED OR SOLD.
- 22 (v) ANY OTHER INFORMATION REQUIRED BY THE DEPARTMENT.
- 23 (B) "VALUE" MEANS THE CURRENT OR FAIR MARKET WORTH IN TERMS
- 24 OF LEGAL MONETARY EXCHANGE AT THE TIME OF SALE OR TRANSFER.
