- 5 (A) THE INDIVIDUAL IS A DEFENDANT IN A CIVIL ACTION BASED ON
- 6 THAT INDIVIDUAL'S COMMUNICATION WITH A GOVERNMENTAL UNIT, A
- 7 PUBLIC OFFICIAL, OR OTHER PERSON IN FURTHERANCE OF THAT
- 8 INDIVIDUAL'S CONSTITUTIONAL RIGHT TO PETITION, INCLUDING SEEKING
