## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 801. (1) The secretary of state shall collect the

- 4 except the fees and taxes provided by law to be paid by certain
- 5 carriers operating motor vehicles and trailers under the motor
- 6 carrier act, 1933 PA 254, MCL 475.1 to 479.43; the taxes imposed
- 7 by the motor carrier fuel tax act, 1980 PA 119, MCL 207.211 to
- 3 207.234; and except as otherwise provided by this act:

- 17 (e) For a hearse or ambulance used exclusively by a licensed
- 18 funeral director in the general conduct of the licensee's funeral
- 19 business, including a hearse or ambulance whose owner is engaged
- 20 in the business of leasing or renting the hearse or ambulance to
- 21 others, \$1.17 per 100 pounds of the empty weight of the hearse or
- 22 ambulance.
- (f) For a vehicle owned and operated by this state, a state
- 24 institution, a municipality, a privately incorporated, nonprofit
- 25 volunteer fire department, or a nonpublic, nonprofit college or
- 26 university, \$5.00 per plate. A registration plate issued under
- 27 this subdivision shall expire on June 30 of the year in which new

- 1 registration plates are reissued for all vehicles by the
- 2 secretary of state.
- 3 (g) For a bus including a station wagon, carryall, or
- 4 similarly constructed vehicle owned and operated by a nonprofit
- 5 parents' transportation corporation used for school purposes,
- 6 parochial school or society, church Sunday school, or any other
- 7 grammar school, or by a nonprofit youth organization or nonprofit
- 8 rehabilitation facility; or a motor vehicle owned and operated by
- 9 a senior citizen center, \$10.00 per set, if the bus, station
- 10 wagon, carryall, or similarly constructed vehicle or motor
- 11 vehicle is designated by proper signs showing the organization
- 12 operating the vehicle.
- (h) For a vehicle owned by a nonprofit organization and used
- 14 to transport equipment for providing dialysis treatment to
- 15 children at camp; for a vehicle owned by the civil air patrol, as
- 16 organized under -sections 40301 to 40307 of title 36 of the
- 17 United States Code, 36 U.S.C. 36 USC 40301 to 40307, \$10.00 per
- 18 plate, if the vehicle is designated by a proper sign showing the
- 19 civil air patrol's name; for a vehicle owned and operated by a
- 20 nonprofit veterans center; for a vehicle owned and operated by a
- 21 nonprofit recycling center or a federally recognized nonprofit
- 22 conservation organization; for a motor vehicle having a truck
- 23 chassis and a locomotive or ship's body -which that is owned by
- 24 a nonprofit veterans organization and used exclusively in parades
- 25 and civic events; or for an emergency support vehicle used
- 26 exclusively for emergencies and owned and operated by a federally
- 27 recognized nonprofit charitable organization, \$10.00 per plate.

- 11 (iv) For the fourth and subsequent registrations, 90% of the
- 12 tax assessed under subparagraph (iii).
- 13 For a vehicle of the 1984 or a subsequent model year that has
- 14 been previously registered by a person other than the person
- 15 applying for registration or for a vehicle of the 1984 or a
- 16 subsequent model year that has been previously registered in
- 17 another state or country and is registered for the first time in
- 18 this state, the tax under this subdivision shall be determined by
- 19 subtracting the model year of the vehicle from the calendar year
- 20 for which the registration is sought. If the result is zero or a
- 21 negative figure, the first registration tax shall be paid. If
- 22 the result is 1, 2, or 3 or more, then, respectively, the second,
- 23 third, or subsequent registration tax shall be paid. A van
- 24 -which- that is owned by an individual who uses a wheelchair or
- 25 by an individual who transports a resident of his or her
- 26 household who uses a wheelchair and for which registration plates
- 27 are issued pursuant to section 803d shall be assessed at the rate

- 1 of 50% of the tax provided for in this subdivision.
- **2** (q) For a wrecker, \$200.00.
- 3 (r) When the secretary of state computes a tax under this
- 4 section, a computation that does not result in a whole dollar
- 5 figure shall be rounded to the next lower whole dollar when the
- 6 computation results in a figure ending in 50 cents or less and
- 7 shall be rounded to the next higher whole dollar when the
- 8 computation results in a figure ending in 51 cents or more,
- 9 unless specific fees are specified, and the secretary of state
- 10 may accept the manufacturer's shipping weight of the vehicle
- 11 fully equipped for the use for which the registration application
- 12 is made. If the weight is not correctly stated or is not
- 13 satisfactory, the secretary of state shall determine the actual
- 14 weight. Each application for registration of a vehicle under
- 15 subdivisions (j) and (m) shall have attached to the application a
- 16 scale weight receipt of the vehicle fully equipped as of the time
- 17 the application is made. The scale weight receipt is not
- 18 necessary if there is presented with the application a
- 19 registration receipt of the previous year -which that shows on
- 20 its face the weight of the motor vehicle as registered with the
- 21 secretary of state and which that is accompanied by a statement
- 22 of the applicant that there has not been a structural change in
- 23 the motor vehicle -which- that has increased the weight and that
- 24 the previous registered weight is the true weight.
- 25 (2) A manufacturer is not exempted under this act from paying
- 26 ad valorem taxes on vehicles in stock or bond, except on the
- 27 specified number of motor vehicles registered. A dealer is

- 1 exempt from paying ad valorem taxes on vehicles in stock or
- 2 bond.
- 3 (3) Until October 1, 2009, the <del>fee</del> tax for a vehicle with
- 4 an empty weight over 10,000 pounds imposed -pursuant to under
- 5 subsection (1)(a) and the fees taxes imposed pursuant to
- 6 under subsection -(1)(b), (c) (1)(c), (d), (e), (f), (i), (j),
- 7 (m), (o), and (p) shall each be increased as follows:
- 8 (a) A regulatory fee of \$2.25, which shall be credited to the
- 9 traffic law enforcement and safety fund created in section 819a
- 10 and used for the purpose of regulating highway safety.
- 11 (b) A fee of \$5.75, which shall be credited to the
- 12 transportation administration collection fund created in section
- **13** 810b.
- 14 (4) If a tax required to be paid under this section is not
- 15 received by the secretary of state on or before the expiration
- 16 date of the registration plate, the secretary of state shall
- 17 collect a late fee of \$10.00 for each registration renewed after
- 18 the expiration date. An application for a renewal of a
- 19 registration using the regular mail and postmarked before the
- 20 expiration date of that registration shall not be assessed a late
- 21 fee. The late fee collected under this subsection shall be
- 22 deposited into the general fund.
- 23 (5) As used in this section:
- (a) "Gross proceeds" means gross proceeds as defined in
- 25 section 1 of the general sales tax act, 1933 PA 167, MCL 205.51.
- 26 However, gross proceeds -shall include includes the value of the
- 27 motor vehicle used as part payment of the purchase price as that

- 1 value is agreed to by the parties to the sale, as evidenced by
- 2 the signed agreement executed pursuant to section 251.
- 3 (b) "List price" means the manufacturer's suggested base list
- 4 price as published by the secretary of state, or the
- 5 manufacturer's suggested retail price as shown on the label
- 6 required to be affixed to the vehicle under section -3 2 of the
- 7 automobile information disclosure act, Public Law 85-506,
- 8 15 U.S.C. 15 USC 1232, if the secretary of state has not at the
- 9 time of the sale of the vehicle published a manufacturer's
- 10 suggested retail price for that vehicle, or the purchase price of
- 11 the vehicle if the manufacturer's suggested base list price is
- 12 unavailable from the sources described in this subdivision.
- 13 (c) "Purchase price" means the gross proceeds received by the
- 14 seller in consideration of the sale of the motor vehicle being
- 15 registered.
