

HOUSE SUBSTITUTE FOR
SENATE BILL NO. 673

A bill to amend 1976 PA 451, entitled
"The revised school code,"
(MCL 380.1 to 380.1852) by adding section 1536; and to repeal acts
and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 1536. (1) THE STATE BOARD SHALL DEVELOP A SCHOOL
2 ADMINISTRATOR'S CERTIFICATE THAT MAY BE ISSUED TO SCHOOL DISTRICT
3 AND INTERMEDIATE SCHOOL DISTRICT SUPERINTENDENTS, SCHOOL
4 PRINCIPALS, ASSISTANT PRINCIPALS, AND OTHER ADMINISTRATORS WHOSE
5 PRIMARY RESPONSIBILITY IS ADMINISTERING INSTRUCTIONAL PROGRAMS. AN
6 INDIVIDUAL IS NOT REQUIRED BY THIS SECTION TO HAVE A SCHOOL
7 ADMINISTRATOR'S CERTIFICATE UNDER THIS SECTION OR AN ENDORSEMENT
8 UNDER SUBSECTION (2) TO BE EMPLOYED AS A SCHOOL ADMINISTRATOR BY A

1 SCHOOL DISTRICT, PUBLIC SCHOOL ACADEMY, INTERMEDIATE SCHOOL
2 DISTRICT, OR NONPUBLIC SCHOOL.

3 (2) THE STATE BOARD ALSO MAY DEVELOP APPROPRIATE CERTIFICATE
4 ENDORSEMENTS FOR SCHOOL ADMINISTRATORS, BY ELEMENTARY, SECONDARY,
5 AND CENTRAL OFFICE LEVEL.

6 (3) THE STATE BOARD SHALL DEVELOP STANDARDS AND PROCEDURES TO
7 IMPLEMENT THIS SECTION. THE STANDARDS AND PROCEDURES SHALL ADDRESS
8 AT LEAST ALL OF THE FOLLOWING:

9 (A) THE EDUCATIONAL AND PROFESSIONAL EXPERIENCE REQUIREMENTS
10 FOR A CERTIFICATE OR ENDORSEMENT UNDER THIS SECTION.

11 (B) CONTINUING EDUCATION REQUIREMENTS FOR PERIODIC
12 RECERTIFICATION. THESE REQUIREMENTS SHALL BE CONSISTENT WITH THE
13 CONTINUING EDUCATION REQUIREMENTS UNDER SECTION 1246.

14 (C) PROCEDURES FOR APPLICATION FOR AND ISSUANCE OF
15 CERTIFICATES AND ENDORSEMENTS UNDER THIS SECTION.

16 (D) STANDARDS AND PROCEDURES FOR SUSPENSION AND REVOCATION OF
17 A CERTIFICATE. THESE STANDARDS AND PROCEDURES SHALL BE BASED ON THE
18 STANDARDS AND PROCEDURES FOR TAKING ACTION AGAINST A PERSON'S
19 TEACHING CERTIFICATE UNDER SECTION 1535A.

20 (4) THE DEPARTMENT SHALL CONSULT AND WORK WITH APPROPRIATE
21 PROFESSIONAL ORGANIZATIONS, PRIMARILY ORGANIZATIONS REPRESENTING
22 SUPERINTENDENTS AND BUILDING-LEVEL ADMINISTRATORS, IN DEVELOPING
23 THE STANDARDS REQUIRED UNDER THIS SECTION.

24 (5) FOR THE PURPOSES OF ADDING 1 OR MORE ENHANCEMENT OR
25 SPECIALTY ENDORSEMENTS FOR A SCHOOL ADMINISTRATOR'S CERTIFICATE,
26 THE DEPARTMENT MAY RECOGNIZE PERFORMANCE-BASED PROFESSIONAL
27 LEARNING PROGRAMS OFFERED BY ESTABLISHED STATE PROFESSIONAL

1 ORGANIZATIONS THAT REPRESENT SCHOOL ADMINISTRATORS DESCRIBED IN
2 SUBSECTION (1). THESE PROGRAMS MUST BE APPROVED BY THE DEPARTMENT
3 BASED ON ALIGNMENT WITH STATE BOARD-APPROVED SCHOOL ADMINISTRATOR
4 PROGRAM PREPARATION STANDARDS.

5 (6) AS USED IN THIS SECTION, "ESTABLISHED STATE PROFESSIONAL
6 ORGANIZATION" MEANS AN ASSOCIATION THAT HAS SERVED MEMBERS ON A
7 STATEWIDE BASIS FOR AT LEAST 10 YEARS.
