

HOUSE BILL No. 4321

February 16, 2005, Introduced by Reps. Moolenaar, Hansen, Walker, Pastor, Mayes, Robertson, Stahl, Shaffer, Booher, Nofs, Acciavatti, Kahn, Caswell, Caul, Kooiman, Pearce, Proos, Jones, Elsenheimer, David Law and Taub and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
(MCL 257.1 to 257.923) by adding section 8110.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 8110. (1) UPON APPLICATION AND SUBJECT TO SUBSECTION (3),
2 THE SECRETARY OF STATE SHALL DEVELOP AND MAY ISSUE A REGISTRATION
3 PLATE WITH AN APPROPRIATE DECAL REPRESENTING THE ROTARY
4 INTERNATIONAL TO AN APPLICANT FOR USE ON THE PASSENGER MOTOR
5 VEHICLE, PICKUP TRUCK, VAN, OR MOTOR HOME FOR WHICH THE PLATE IS
6 ISSUED. THE DECAL SHALL CONTAIN THE ROTARY INTERNATIONAL LOGO AND
7 THE WORDS "100 YEARS".
8 (2) AN APPLICATION FOR A REGISTRATION PLATE WITH THE ROTARY

1 INTERNATIONAL DECAL SHALL BE SUBMITTED TO THE SECRETARY OF STATE
2 PURSUANT TO THE PROCEDURES PRESCRIBED IN SECTION 217. IN ADDITION
3 TO THE REGULAR REGISTRATION TAX IMPOSED BY SECTION 801, EACH
4 APPLICATION SHALL BE ACCOMPANIED WITH PAYMENT OF \$3.00 FOR THE
5 FIRST MONTH AND \$2.00 PER MONTH FOR EACH ADDITIONAL MONTH OF THE
6 REGISTRATION PERIOD OF THE PLATE. REGISTRATION PLATES WITH THE
7 ROTARY INTERNATIONAL DECAL SHALL EXPIRE ON THE APPLICANT'S BIRTHDAY
8 AS PROVIDED IN SECTION 226.

9 (3) THE ROTARY INTERNATIONAL MAY SUBMIT TO THE SECRETARY OF
10 STATE A DESIGN OF A SEPARATE DECAL TO BE AFFIXED TO A REGISTRATION
11 PLATE TO IMPLEMENT THIS SECTION. THE SECRETARY OF STATE SHALL
12 CONFER WITH THE DEPARTMENT OF STATE POLICE TO ENSURE THE DESIGN
13 WILL NOT COMPROMISE THE ABILITY OF LAW ENFORCEMENT AGENCIES TO
14 ACCURATELY IDENTIFY SPECIFIC VEHICLES. REGISTRATION PLATES WITH THE
15 ROTARY INTERNATIONAL DECAL SHALL NOT BE A DUPLICATION OF ANOTHER
16 REGISTRATION PLATE.

17 (4) THE SECRETARY OF STATE MAY ISSUE A TEMPORARY REGISTRATION
18 PERMIT TO A PERSON WHO SUBMITS AN APPLICATION AND THE PROPER
19 PAYMENTS FOR A REGISTRATION PLATE WITH THE ROTARY INTERNATIONAL
20 DECAL, IF THE APPLICANT'S CURRENT VEHICLE REGISTRATION WILL EXPIRE
21 BEFORE HIS OR HER RECEIPT OF A REGISTRATION PLATE WITH THE ROTARY
22 INTERNATIONAL DECAL. THE TEMPORARY REGISTRATION SHALL EXPIRE UPON
23 RECEIPT OF A REGISTRATION PLATE WITH THE ROTARY INTERNATIONAL DECAL
24 OR 60 DAYS AFTER THE ISSUANCE, WHICHEVER OCCURS FIRST. THE
25 TEMPORARY PERMIT SHALL BE ISSUED WITHOUT A SEPARATE FEE.
