A bill to amend 1976 PA 451, entitled "The revised school code," (MCL 380.1 to 380.1852) by adding section 1212a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1212A. (1) IN ADDITION TO THE PURPOSES SPECIFIED IN
- 2 SECTION 1212(1), A SCHOOL DISTRICT THAT CREATES A SINKING FUND AND
- 3 LEVIES A SINKING FUND TAX UNDER SECTION 1212 MAY USE THE SINKING
- 4 FUND FOR THE PURCHASE OF SCHOOL BUSES OR THE ACQUISITION,
- 5 INSTALLATION, OR EQUIPPING OR REEQUIPPING OF SCHOOL BUILDINGS FOR
- 6 TECHNOLOGY.
 - (2) A SCHOOL DISTRICT SHALL NOT LEVY A TAX FOR A SINKING FUND
- 8 UNDER SECTION 1212 OR USE THE SINKING FUND TO DEFRAY ALL OR PART OF
 - THE COSTS OF ANY OF THE FOLLOWING:
 - (A) UPGRADES TO OPERATING SYSTEM OR APPLICATION SOFTWARE.

- 12 OR COMPUTE INFORMATION FOR PUPIL INSTRUCTIONAL PURPOSES.
- 13 (ii) THE INITIAL PURCHASE OF OPERATING SYSTEM SOFTWARE OR
- 14 CUSTOMIZED APPLICATION SOFTWARE, OR BOTH, ACCOMPANYING THE PURCHASE
- 15 OF HARDWARE AND COMMUNICATION DEVICES UNDER SUBPARAGRAPH (i).
- 16 (iii) THE COSTS OF DESIGN AND INSTALLATION OF THE HARDWARE,
- 17 COMMUNICATION DEVICES, AND INITIAL OPERATING SYSTEM SOFTWARE OR
