HOUSE BILL No. 5720

EXECUTIVE BUDGET BILL

February 21, 2006, Introduced by Rep. Brown and referred to the Committee on Appropriations.

A bill to make appropriations for the department of agriculture for the fiscal year ending September 30, 2007; to provide for the expenditure of the appropriations; to create funds; to provide for the imposition of fees; to require reports, audits, and plans; to authorize certain transfers by certain state agencies; and to provide for the disposition of fees and other income received by certain state agencies.

7	Sec. 201. Pursuant to section 30 of article IX of the state
8	constitution of 1963, total state spending from state resources
9	under part 1 for fiscal year 2006-2007 is \$78,461,500.00 and state
10	spending from state resources to be paid to local units of
11	government for fiscal year 2006-2007 is \$3,141,000.00. The itemized
12	statement below identifies appropriations from which spending to
13	units of local government will occur:

18	Sec. 202. The appropriations authorized under this bill are
19	subject to the management and budget act, 1984 PA 431, MCL 18.1101
20	to 18.1594.
21	Sec. 203. As used in this bill:
22	(a) "DAG" means the United States department of agriculture.
23	(b) "Department" means the department of agriculture.
24	(c) "Director" means the director of the department.
25	(d) "EPA" means the United States environmental protection

- 1 agency.
- 2 (e) "FFA" means future farmers of America.
- 3 (f) "FTE" means full-time equated.
- 4 (g) "HHS-FDA" means the United States department of health and
- 5 human services food and drug administration.
- 6 (h) "IDG" means interdepartmental grant.
- 7 (i) "MAEAP" means the Michigan agriculture environmental
- 8 assurance program.
- 9 (j) "MDCH" means the Michigan department of community health.
- 10 (k) "MDLEG (LCC)" means the Michigan department of labor and
- 11 economic growth liquor control commission.
- 12 (1) "MDEQ" means the Michigan department of environmental
- 13 quality.
- 14 (m) "MDNR" means the Michigan department of natural resources.
- (n) "USDA" means the United States department of agriculture.
- Sec. 204. The department of civil service shall bill
- 17 departments and agencies at the end of the first fiscal quarter for
- 18 the 1% charge authorized by section 5 of article XI of the state
- 19 constitution of 1963. Payments shall be made for the total amount
- 20 of the billing by the end of the second fiscal quarter.
- 21 Sec. 205. (1) A hiring freeze is imposed on the state
- 22 classified civil service. State departments and agencies are
- 23 prohibited from hiring any new full-time state classified civil
- 24 service employees and prohibited from filling any vacant state
- 25 classified civil service positions. This hiring freeze does not
- 26 apply to internal transfers of classified employees from 1 position
- 27 to another within a department.

- 1 (2) The state budget director may grant exceptions to this
- 2 hiring freeze when the state budget director believes that the
- 3 hiring freeze will result in rendering a state department or agency
- 4 unable to deliver basic services, cause loss of revenue to the
- 5 state, result in the inability of the state to receive federal
- 6 funds, or necessitate additional expenditures that exceed any
- 7 savings from maintaining a vacancy. The state budget director shall
- 8 report quarterly to the chairpersons of the senate and house of
- 9 representatives standing committees on appropriations the number of
- 10 exceptions to the hiring freeze approved during the previous
- 11 quarter and the reasons to justify the exception.
- 12 Sec. 208. Unless otherwise specified, the department shall use
- 13 the Internet to fulfill the reporting requirements of this bill.
- 14 This requirement may include transmission of reports via electronic
- 15 mail to the recipients identified for each reporting requirement,
- 16 or it may include placement of reports on an Internet or Intranet
- **17** site.
- 18 Sec. 209. Funds appropriated in part 1 shall not be used for
- 19 the purchase of foreign goods or services, or both, if
- 20 competitively priced and of comparable quality American goods or
- 21 services, or both, are available. Preference should be given to
- 22 goods or services, or both, manufactured or provided by Michigan
- 23 businesses if they are competitively priced and of comparable
- 24 quality.
- 25 Sec. 210. The director shall take all reasonable steps to
- 26 ensure businesses in deprived and depressed communities compete for
- 27 and perform contracts to provide services or supplies, or both. The

- 1 director shall strongly encourage firms with which the department
- 2 contracts to subcontract with certified businesses in depressed and
- 3 deprived communities for services, supplies, or both.
- 4 Sec. 212. Of the funds appropriated in part 1, the department
- 5 may provide for indemnity as provided for pursuant to the
- 6 animal industry act of 1987, 1988 PA 466, MCL 287.701 to
- 7 287.745, not to exceed \$100,000.00 per order from any line
- 8 item for the fiscal year ending September 30, 2007. Before the
- 9 department provides for an indemnification under this section,
- 10 the department shall report the reason for the
- 11 indemnification, the amount of the indemnification, and to
- 12 whom the indemnification is to be paid. The report shall be
- 13 given to each member of the house and senate appropriations
- 14 subcommittees on agriculture and to the senate and house
- 15 fiscal agencies and the state budget director.
- Sec. 219. From the funds appropriated in part 1 for
- 17 information technology, departments and agencies shall pay user
- 18 fees to the department of information technology for technology-
- 19 related services and projects. Such user fees shall be subject to
- 20 provision of an interagency agreement between the departments and
- 21 agencies and the department of information technology.
- 22 Sec. 220. Amounts appropriated in part 1 for information
- 23 technology may be designated as work projects and carried forward
- 24 to support technology projects under the direction of the
- 25 department of information technology. Funds designated in this
- 26 manner are not available for expenditure until approved as work
- 27 projects under section 451a of the management and budget act, 1984

- **1** PA 431, MCL 18.1451a.
- 2 Sec. 223. (1) Due to the current budgetary problems in this
- 3 state, out-of-state travel for the fiscal year ending September 30,
- 4 2007 shall be limited to situations in which 1 or more of the
- 5 following conditions apply:
- 6 (a) The travel is required by legal mandate or court order or
- 7 for law enforcement purposes.
- 8 (b) The travel is necessary to protect the health or safety of
- 9 Michigan citizens or visitors or to assist other states in similar
- 10 circumstances.
- 11 (c) The travel is necessary to produce budgetary savings or to
- 12 increase state revenues, including protecting existing federal
- 13 funds or securing additional federal funds.
- 14 (d) The travel is necessary to comply with federal
- 15 requirements.
- 16 (e) The travel is necessary to secure specialized training for
- 17 staff that is not available within this state.
- 18 (f) The travel is financed entirely by federal or nonstate
- 19 funds.
- 20 (2) If out-of-state travel is necessary but does not meet 1 or
- 21 more of the conditions in subsection (1), the state budget director
- 22 may grant an exception to allow the travel. Any exceptions granted
- 23 by the state budget director shall be reported on a monthly basis
- 24 to the senate and house of representatives standing committees on
- 25 appropriations.
- 26 (3) Not later than January 1 of each year, each department
- 27 shall prepare a travel report listing all travel by classified and

- 1 unclassified employees outside this state in the immediately
- 2 preceding fiscal year that was funded in whole or in part with
- 3 funds appropriated in the department's budget. The report shall be
- 4 submitted to the chairs and members of the senate and house of
- 5 representatives standing committees on appropriations, the fiscal
- 6 agencies, and the state budget director. The report shall include
- 7 the following information:
- 8 (a) The name of each person receiving reimbursement for travel
- 9 outside this state or whose travel costs were paid by this state.
- 10 (b) The destination of each travel occurrence.
- 11 (c) The dates of each travel occurrence.
- 12 (d) A brief statement of the reason for each travel
- 13 occurrence.
- 14 (e) The transportation and related costs of each travel
- 15 occurrence, including the proportion funded with state general
- 16 fund/general purpose revenues, the proportion funded with state
- 17 restricted revenues, the proportion funded with federal revenues,
- 18 and the proportion funded with other revenues.
- 19 (f) A total of all out-of-state travel funded for the
- 20 immediately preceding fiscal year.
- 21 Sec. 225. (1) In addition to the funds appropriated in part 1,
- there is appropriated an amount not to exceed \$5,000,000.00 for
- 23 federal contingency funds. These funds are not available for
- 24 expenditure until they have been transferred to another line item
- 25 in this bill under section 393(2) of the department of management
- 26 and budget act, 1984 PA 431, MCL 18.1393.
- 27 (2) In addition to the funds appropriated in part 1, there is

- 1 appropriated an amount not to exceed \$6,000,000.00 for state
- 2 restricted contingency funds. These funds are not available for
- 3 expenditure until they have been transferred to another line item
- 4 in this bill under section 393(2) of the department of management
- 5 and budget act, 1984 PA 431, MCL 18.1393.
- **6** (3) In addition to the funds appropriated in part 1, there is
- 7 appropriated an amount not to exceed \$100,000.00 for local
- 8 contingency funds. These funds are not available for expenditure
- 9 until they have been transferred to another line item in this bill
- 10 under section 393(2) of the department of management and budget
- 11 act, 1984 PA 431, MCL 18.1393.
- 12 (4) In addition to the funds appropriated in part 1, there is
- appropriated an amount not to exceed \$100,000.00 for private
- 14 contingency funds. These funds are not available for expenditure
- 15 until they have been transferred to another line item in this bill
- 16 under section 393(2) of the department of management and budget
- 17 act, 1984 PA 431, MCL 18.1393.

18 EXECUTIVE

- 19 Sec. 302. The department may receive and expend revenue and
- 20 use that revenue to cover necessary expenses related to
- 21 publications, audit and licensing functions, livestock sales,
- 22 certification of nursery stock, bean inspection services, and
- 23 laboratory analyses as specified in the following:
- 24 (a) Management services publications.
- 25 (b) Management services audit and licensing functions.
- 26 (c) Pesticide and plant pest management propagation and

- 1 certification of virus free foundation stock.
- 2 (d) Pesticide and plant pest management bean inspection and
- 3 grading services.
- 4 (e) Laboratory support testing for testing horses in draft
- 5 horse pulling contests at county fairs when local jurisdictions
- 6 request state assistance.
- 7 (f) Laboratory support analyses to determine foreign
- 8 substances in horses engaged in racing or pulling contests at
- 9 tracks.
- 10 (g) Laboratory support analysis of food, livestock, and
- 11 agricultural products for disease, foreign products for disease,
- 12 toxic materials, foreign substances, and quality standards.
- 13 (h) Laboratory support test samples for other agencies and
- 14 organizations.
- 15 (i) Fruit and vegetable inspection at shipping and termination
- 16 points and processing plants.

17 FOOD AND DAIRY

- 18 Sec. 401. The department shall monitor restaurant inspection
- 19 and licensing functions carried out by local health departments to
- 20 ensure uniform application and enforcement of minimum program
- 21 requirements.

22 ANIMAL INDUSTRY

- 23 Sec. 450. From the funds appropriated in section 105 for the
- 24 bovine tuberculosis program, the department shall reimburse the
- 25 department of natural resources for those costs associated with

- 1 monitoring and testing wildlife for bovine tuberculosis that are
- 2 necessary to support the department goals and are jointly agreed to
- 3 by the department and the department of natural resources to be in
- 4 excess of efforts necessary to effectively plan and execute the
- 5 eradication of bovine tuberculosis from Michigan's wild free-
- 6 ranging deer herd.
- 7 Sec. 451. From the funds appropriated in section 105 for
- 8 bovine tuberculosis, the department shall pay for all whole herd
- 9 testing costs and individual animal testing costs in the modified
- 10 accredited zone to maintain split-state status requirements. These
- 11 costs include indemnity and compensation for injury causing death
- 12 or downer to animals.

ENVIRONMENTAL STEWARDSHIP

- Sec. 604. The appropriation in section 107 for local
- 15 conservation districts shall be allocated in the following manner:
- 16 (a) Of the total appropriation, each local conservation
- 17 district meeting the minimum grant requirements shall receive a
- 18 grant of \$18,200.00 to support basic operations, unless the
- 19 district resides in a county consisting of multiple districts, in
- 20 which case a \$18,200.00 grant shall be divided equally among the
- 21 districts in that county. The amount of money allocated under this
- 22 subdivision shall not be used by local conservation districts to
- 23 replace any money received from local sources.
- 24 (b) Any amount remaining from the appropriation after
- 25 distributions under subdivision (a) shall be allocated for local
- 26 conservation district training.

AGRICULTURE DEVELOPMENT

- 2 Sec. 702. In any given year when insufficient amounts of
- 3 Michigan surplus products are offered to the food bank council and
- 4 accepted for distribution, unused funds may be applied by the food
- 5 bank council for the direct purchase of foods from Michigan
- 6 growers, manufacturers, or wholesalers.

7 FAIRS AND EXPOSITIONS

- 8 Sec. 802. From the amount appropriated in section 110 for
- 9 purses and supplements fairs/licensed tracks, \$280,000.00 is to
- 10 be used for state purse supplements at state licensed pari-mutuel
- 11 tracks for races comprised only of Michigan-bred horses segregated
- 12 into a 4-year-old colt trot division, a 4-year-old filly trot
- 13 division, a 4-year-old colt pace division, and a 4-year-old filly
- 14 pace division.
- 15 Sec. 803. Included in the appropriation made in section 110
- 16 for the thoroughbred program is \$30,500.00 for the Michigan united
- 17 thoroughbred breeders and owners association to conduct a
- 18 thoroughbred yearling show. The Michigan united thoroughbred
- 19 breeders and owners association shall submit to the department an
- 20 itemized list of expenses showing that the expenses of the yearling
- 21 show were paid.
- Sec. 804. From the funds appropriated in section 110 for
