February 22, 2006, Introduced by Rep. Caswell and referred to the Committee on Government Operations.

A bill to amend 1974 PA 258, entitled
"Mental health code,"
by amending sections 114 and 114a (MCL 330.1114 and 330.1114a),
section 114 as amended and section 114a as added by 1995 PA 290.

1 Sec. 114. (1) Subject to section 114a, as provided in section
