- 1 SEC. 8637. (1) THE CAFO CLEANUP AND ENFORCEMENT FUND IS
- 2 CREATED WITHIN THE STATE TREASURY.
- 3 (2) THE STATE TREASURER SHALL DEPOSIT INTO THE FUND REVENUE AS
- 4 SPECIFIED UNDER SECTIONS 3115, 3120, AND 8623. THE STATE TREASURER
- 5 MAY RECEIVE MONEY OR OTHER ASSETS FROM ANY OTHER SOURCE FOR DEPOSIT
- 6 INTO THE FUND. THE STATE TREASURER SHALL DIRECT THE INVESTMENT OF
- 7 THE FUND. THE STATE TREASURER SHALL CREDIT TO THE FUND INTEREST AND
- 8 EARNINGS FROM FUND INVESTMENTS.
