## **HOUSE BILL No. 5966**

A bill to amend 1961 PA 236, entitled

"Revised judicature act of 1961,"

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2567a. (1) Except as otherwise provided in subsection
- 2 (4), the county register of deeds shall collect a fee for recording
- 3 any instrument. Before January 1,  $\frac{2013}{}$  2023, the fee shall be
- **4** \$4.00. Beginning January 1,  $\frac{2013}{}$  **2023**, the fee shall be \$2.00.
- 5 The fee shall be paid when the instrument is left for record.
- 6 (2) The fee required by this section is in addition to any
  - fees required in section 2567 or fees or charges otherwise required
  - by law for the recording of instruments.
    - (3) The fees collected under this section shall be remitted to

- 1 the state treasurer quarterly, and shall be deposited by the state
- 2 treasurer in the survey and remonumentation fund created in section
