September 14, 2006, Introduced by Rep. Stahl and referred to the Committee on House Oversight, Elections, and Ethics.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 11d of chapter XVII (MCL 777.11d), as added  
by 2002 PA 31.
