

HOUSE BILL No. 6555

September 20, 2006, Introduced by Rep. Kolb and referred to the Committee on Local Government and Urban Policy.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 2a of chapter IV (MCL 764.2a), as amended by 2002 PA 483.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

CHAPTER IV

Sec. 2a. (1) A peace officer of a county, city, village, township, or university of this state may exercise the authority and powers of a peace officer outside the geographical boundaries of the officer's county, city, village, township, or university under any of the following circumstances:

(a) If the officer is enforcing the laws of this state in conjunction with the Michigan state police.

(b) If the officer is enforcing the laws of this state in

1 conjunction with a peace officer of any other county, city,
2 village, township, or university in which the officer may be.

3 (c) If the officer has witnessed an individual violate any of
4 the following within the geographical boundaries of the officer's
5 county, city, village, township, or university and immediately
6 pursues the individual outside of the geographical boundaries of
7 the officer's county, city, village, township, or university:

8 (i) A state law or administrative rule.

9 (ii) A local ordinance.

10 (iii) A state law, administrative rule, or local ordinance, the
11 violation of which is a civil infraction, municipal civil
12 infraction, or state civil infraction.

13 (2) The officer pursuing an individual under subsection (1)(c)
14 may stop and detain the person outside the geographical boundaries
15 of the officer's county, city, village, township, or university for
16 the purpose of enforcing that law, administrative rule, or
17 ordinance or enforcing any other law, administrative rule, or
18 ordinance before, during, or immediately after the detaining of the
19 individual. If the violation or pursuit involves a vessel moving on
20 the waters of this state, the officer pursuing the individual may
21 direct the operator of the vessel to bring the vessel to a stop or
22 maneuver it in a manner that permits the officer to come beside the
23 vessel.

24 (3) **IN ADDITION TO THE AUTHORITY PRESCRIBED IN SUBSECTIONS (1)**
25 **AND (2), A PEACE OFFICER OF A COUNTY, CITY, VILLAGE, OR TOWNSHIP OF**
26 **THIS STATE MAY EXERCISE THE AUTHORITY AND POWERS OF A PEACE OFFICER**
27 **ANYWHERE WITHIN AN ADJACENT COUNTY, CITY, VILLAGE, OR TOWNSHIP IF**

1 THE LEGISLATIVE BODY OF THE COUNTY, CITY, TOWNSHIP, OR VILLAGE
2 HAVING JURISDICTION OVER THE LAW ENFORCEMENT AGENCY AND THE
3 LEGISLATIVE BODY OF THE ADJACENT COUNTY, CITY, VILLAGE, OR TOWNSHIP
4 ENTER INTO A WRITTEN AGREEMENT FOR THAT PURPOSE. AS USED IN THIS
5 SUBSECTION, "ADJACENT COUNTY, CITY, VILLAGE, OR TOWNSHIP" MEANS A
6 COUNTY, CITY, VILLAGE, OR TOWNSHIP THAT HAS A BORDER IN COMMON WITH
7 THE COUNTY, CITY, TOWNSHIP, OR VILLAGE THAT HAS JURISDICTION OVER
8 THE LAW ENFORCEMENT AGENCY EMPLOYING THE PEACE OFFICER.
