

SENATE BILL No. 79

January 25, 2005, Introduced by Senator McMANUS and referred to the Committee on Natural Resources and Environmental Affairs.

A bill to amend 1967 (Ex Sess) PA 7, entitled "Urban cooperation act of 1967," by amending section 8a (MCL 124.508a), as amended by 1996 PA 45.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 8a. (1) Subject to the requirement of ~~subsection (2)~~
 2 **SUBSECTIONS (2) AND (3)**, a county ~~—, by resolution of the county~~

16 (2) **A COUNTY OR AGENCY SHALL NOT IMPOSE A SURCHARGE OR FEE**
17 **ALLOWED UNDER SUBSECTION (1) WITHOUT THE APPROVAL OF THE VOTERS**
18 **WITHIN THE COUNTY AT A REGULARLY SCHEDULED ELECTION.**

19 (3) ~~(2)~~ A county or agency shall defer the imposition and
20 collection of a surcharge imposed under subsection (1) in a local
21 unit of government within that county until the county or agency
22 has entered into an interlocal agreement under this act relating to
23 the collection and disposition of the surcharge with the local unit
24 of government. ~~However, a~~ **A** city in a county in which the agency
25 described in subsection (1) prepared the update to the county's
26 solid waste management plan as provided in part 115 of ~~Act No. 451~~
27 ~~of the Public Acts of 1994~~ **THE NATURAL RESOURCES AND ENVIRONMENTAL**

1 **PROTECTION ACT, 1994 PA 451, MCL 324.11501 TO 324.11550**, shall not
2 enter into an interlocal agreement ~~under this subsection~~ if the
3 city has levied a tax of 3 mills on real property within the city
4 for the disposal or management of solid waste in that city.
5 Petitions for a referendum election on the question of entering an
6 interlocal agreement ~~under this subsection~~ may be filed with the
7 ~~local units~~ clerk **OF THE LOCAL UNIT OF GOVERNMENT** no later than 6
8 months following adoption of a resolution of the county or agency
9 to impose the surcharge or 6 months following any increase in the
10 surcharge. Upon petition of 10% of the qualified electors of a
11 local unit of government voting in the last general election ~~prior~~
12 ~~to~~ **BEFORE** the adoption of the interlocal agreement by the
13 governing body, the local unit of government shall hold a
14 referendum on whether to reject the entrance into or terminate an
15 interlocal agreement. ~~under this subsection.~~

16 **(4) THE SURCHARGE APPROVED UNDER SUBSECTION (1) MAY BE**
17 **COLLECTED BY ANY REASONABLE BILLING METHOD APPROVED BY THE COUNTY,**
18 **INCLUDING, BUT NOT LIMITED TO, AS PART OF BILLINGS FOR PROPERTY**
19 **TAXES, WATER AND SEWAGE USAGE, OR OTHER SERVICES PROVIDED BY THE**
20 **COUNTY TO HOUSEHOLDS WITHIN THE COUNTY.**

21 **(5) ~~(3)~~** As used in this section, agency does not include
22 the department of natural resources.
