- 1 An act to define civil rights; to prohibit discriminatory
- 2 practices, policies, and customs in the exercise of those rights
- 3 based upon religion, race, color, national origin, age, sex, SEXUAL
- 4 ORIENTATION, height, weight, familial status, or marital status; to
- 5 preserve the confidentiality of records regarding arrest,
- 6 detention, or other disposition in which a conviction does not
- 7 result; to prescribe the powers and duties of the civil rights

- 10 Sec. 102. (1) The opportunity to obtain employment, housing

- 3 discriminate against, an individual because of religion, race,
- 4 color, national origin, age, sex, SEXUAL ORIENTATION, GENDER
- 5 IDENTITY OR EXPRESSION, height, weight, or marital status; or
- 6 classify or refer for employment an individual on the basis of
- 7 religion, race, color, national origin, age, sex, SEXUAL
- 8 ORIENTATION, GENDER IDENTITY OR EXPRESSION, height, weight, or
- 9 marital status.
- 10 Sec. 204. A labor organization shall not DO ANY OF THE
- 11 FOLLOWING:
- 12 (a) Exclude or expel from membership, or otherwise
- 13 discriminate against, a member or applicant for membership because
- 14 of religion, race, color, national origin, age, sex, SEXUAL
- 15 ORIENTATION, GENDER IDENTITY OR EXPRESSION, height, weight, or
- 16 marital status.
- 17 (b) Limit, segregate, or classify membership or applicants for
- 18 membership, or classify or fail or refuse to refer for employment
- 19 an individual in a way -which THAT would deprive or tend to
- 20 deprive that individual of an employment opportunity, or -which
- 21 THAT would limit an employment opportunity, or -which- THAT would
- 22 adversely affect wages, hours, or employment conditions, or
- 23 otherwise adversely affect the status of an employee or an

- 27 color, national origin, or sex, SEXUAL ORIENTATION, OR GENDER

- 2 (b) Exclude, expel, limit, or otherwise discriminate against
- 3 an individual seeking admission as a student or an individual
- 4 enrolled as a student in the terms, conditions, or privileges of
- 5 the institution, because of religion, race, color, national origin,
- 6 er sex, sexual orientation, or gender identity or expression.
- 7 (c) For purposes of admission only, make or use a written or
- 8 oral inquiry or form of application that elicits or attempts to
- 9 elicit information concerning the religion, race, color, national
- 10 origin, age, sex, SEXUAL ORIENTATION, GENDER IDENTITY OR
- 11 EXPRESSION, or marital status of a person, except as permitted by
- 12 rule of the commission or as required by federal law, rule, or
- 13 regulation, or pursuant to an affirmative action program.
- 14 (d) Print or publish or cause to be printed or published a
- 15 catalog, notice, or advertisement indicating a preference,
- 16 limitation, specification, or discrimination based on the religion,
- 17 race, color, national origin, -or sex, SEXUAL ORIENTATION, OR
- 18 GENDER IDENTITY OR EXPRESSION, of an applicant for admission to the
- 19 educational institution.
- (e) Announce or follow a policy of denial or limitation
- 21 through a quota or otherwise of educational opportunities of a
- 22 group or its members because of religion, race, color, national
- 23 origin, —or— sex, SEXUAL ORIENTATION, OR GENDER IDENTITY OR
- 24 EXPRESSION.
- 25 Sec. 502. (1) A person engaging in a real estate transaction,
- 26 or a real estate broker or salesman, shall not on the basis of
- 27 religion, race, color, national origin, age, sex, SEXUAL

- 1 ORIENTATION, GENDER IDENTITY OR EXPRESSION, familial status, or
- 2 marital status of a person or a person residing with that person DO
- 3 ANY OF THE FOLLOWING:
- 4 (a) Refuse to engage in a real estate transaction with a
- 5 person.
- 6 (b) Discriminate against a person in the terms, conditions, or
- 7 privileges of a real estate transaction or in the furnishing of
- 8 facilities or services in connection with a real estate
- 9 transaction.
- (c) Refuse to receive from a person or transmit to a person a
- 11 bona fide offer to engage in a real estate transaction.
- 12 (d) Refuse to negotiate for a real estate transaction with a
- 13 person.
- 14 (e) Represent to a person that real property is not available
- 15 for inspection, sale, rental, or lease when in fact it is so
- 16 available, or knowingly fail to bring a property listing to a
- 17 person's attention, or refuse to permit a person to inspect real
- 18 property, or otherwise make unavailable or deny real property to a
- 19 person.
- 20 (f) Make, print PRINT, circulate, post, mail, or otherwise
- 21 cause to be made or published MAKE OR PUBLISH a statement,
- 22 advertisement, notice, or sign, or use a form of application for a
- 23 real estate transaction, or make a record of inquiry in connection
- 24 with a prospective real estate transaction, -which THAT indicates,
- 25 directly or indirectly, an intent to make a preference, limitation,
- 26 specification, or discrimination with respect to the real estate
- 27 transaction.

- 1 (g) Offer, solicit, accept, use, or retain a listing of real
- 2 property with the understanding that a person may be discriminated
- 3 against in a real estate transaction or in the furnishing of
- 4 facilities or services in connection therewith WITH A REAL ESTATE
- 5 TRANSACTION.
- 6 (h) Discriminate against a person in the brokering or
- 7 appraising of real property.
- 8 (2) A person shall not deny a person access to, or membership
- 9 or participation in, a multiple listing service, real estate
- 10 brokers' organization or other service, organization, or facility
- 11 relating to the business of selling or renting real property or to
- 12 discriminate against him or her in the terms or conditions of that
- 13 access, membership, or participation because of religion, race,
- 14 color, national origin, age, sex, SEXUAL ORIENTATION, GENDER
- 15 IDENTITY OR EXPRESSION, familial status, or marital status.
- 16 (3) This section is subject to section 503.
- 17 Sec. 504. (1) A person to whom application is made for

- 25 marital status of the applicant or a person residing with the

- 27 (b) Use a form of application for financial assistance or

- 1 financing or make or keep a record or inquiry in connection with an
- 2 application for financial assistance or financing -which THAT
- 3 indicates, directly or indirectly, a preference, limitation,
- 4 specification, or discrimination as to the religion, race, color,
- 5 national origin, age, sex, SEXUAL ORIENTATION, GENDER IDENTITY OR
- 6 EXPRESSION, familial status, or marital status of the applicant or
- 7 a person residing with the applicant.
- 8 (2) A person whose business includes engaging in real estate
- 9 transactions shall not discriminate against a person because of

- 11 ORIENTATION, GENDER IDENTITY OR EXPRESSION, familial status, or
- 12 marital status, in the purchasing of loans for acquiring,

- Sec. 505. (1) A condition, restriction, or prohibition,
