

SENATE BILL No. 1424

September 12, 2006, Introduced by Senators McMANUS, JELINEK, BROWN, BIRKHOLZ, KUIPERS, CHERRY, GOSCHKA, ALLEN, SCOTT, OLSHOVE, BARCIA, SWITALSKI, BASHAM, CLARK-COLEMAN and BRATER and referred to the Committee on Natural Resources and Environmental Affairs.

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
by amending section 806 (MCL 257.806), as amended by 2005 PA 179.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 806. (1) Until October 1, 2009, a fee of \$10.00 shall
2 accompany each application for a certificate of title required by
3 this act or for a duplicate of a certificate of title. An
4 additional fee of \$5.00 shall accompany an application if the
5 applicant requests that the application be given special
6 expeditious treatment. A \$3.00 service fee shall be collected, in
7 addition to the other fees collected under this subsection, for
8 each title issued. The \$5.00 expeditious treatment fee collected on
9 and after October 1, 2004 through September 30, 2006 shall be

1 deposited into the transportation administration collection fund
2 created under section 810b. The \$5.00 expeditious treatment fee
3 collected on and after October 1, 2006 shall be deposited into the
4 Michigan transportation fund established under section 10 of 1951
5 PA 51, MCL 247.660. The \$3.00 service fee shall be deposited into
6 the transportation administration collection fund created under
7 section 810b.

8 (2) A fee of \$10.00 shall accompany an application for a
9 special identifying number as provided in section 230.

10 (3) In addition to paying the fees required by subsection (1),
11 until December 31, ~~2007~~ 2012, each person who applies for a
12 certificate of title, a salvage vehicle certificate of title, or a
13 scrap certificate of title, under this act shall pay a tire
14 disposal surcharge of \$1.50 for each certificate of title or
15 duplicate of a certificate of title that person receives. The
16 secretary of state shall deposit money received under this
17 subsection into the scrap tire regulatory fund created in section
18 16908 of the natural resources and environmental protection act,
19 1994 PA 451, MCL 324.16908.

20 Enacting section 1. This amendatory act does not take effect
21 unless all of the following bills of the 93rd Legislature are
