## **SENATE BILL No. 1434**

September 14, 2006, Introduced by Senator HAMMERSTROM and referred to the Committee on Government Operations.

A bill to amend 1954 PA 116, entitled "Michigan election law,"

(MCL 168.1 to 168.992) by adding section 661a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 661A. (1) BEGINNING JANUARY 1, 2007, THE SECRETARY OF
- 2 STATE SHALL ESTABLISH A PILOT PROJECT TO TEST SUPER VOTER PRECINCTS
- 3 IN THIS STATE. THE SECRETARY OF STATE SHALL SELECT THE LOCAL UNITS
- 4 OF GOVERNMENT IN WHICH TO TEST PILOT PROJECT SUPER VOTER PRECINCTS
- 5 UNDER THIS SECTION.
- 6 (2) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION, A PILOT
- 7 PROJECT SUPER VOTER PRECINCT SHALL ONLY BE USED ON A REGULAR
- 8 ELECTION DATE AS PROVIDED IN SECTION 641(1)(A) THROUGH (D). A PILOT
  - PROJECT SUPER VOTER PRECINCT SHALL NOT BE USED AT A GENERAL

- 19 (5) IF A PILOT PROJECT SUPER VOTER PRECINCT IS USED IN A LOCAL
- 20 UNIT OF GOVERNMENT UNDER THIS SECTION, A PRECINCT POLLING PLACE
- 21 ESTABLISHED UNDER SECTION 662 SHALL NOT BE USED IN THAT LOCAL UNIT
- 22 OF GOVERNMENT UNLESS THE PRECINCT POLLING PLACE HAS A SECURE
- 23 ELECTRONIC CONNECTION TO PROVIDE VOTING INFORMATION TO AND VOTING
- 24 INFORMATION FROM THE QUALIFIED VOTER FILE.
- 25 (6) A PILOT PROJECT SUPER VOTER PRECINCT SHALL NOT EXCEED
- 26 10,000 ACTIVE REGISTERED ELECTORS.
- 27 (7) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, EACH PILOT
