September 14, 2006, Introduced by Senator McMANUS and referred to the Committee on Government Operations.

A bill to amend 1954 PA 116, entitled "Michigan election law,"

by amending section 22a (MCL 168.22a), as added by 1995 PA 261.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 22a. (1) On or before the tenth day of January in an odd
- 2 numbered year, the state central committee of each major political
- 3 party shall, SUBJECT TO THE REQUIREMENT IN SUBSECTION (4), submit
- 4 to the governor the names of 3 individuals as nominees for each

- 1 individual from the 3 individuals nominated to each position of the

- 18 STATE CANVASSERS SHALL BE A FORMER COUNTY, CITY, TOWNSHIP, OR
- 19 VILLAGE CLERK OR FORMER ELECTION OFFICIAL.
