"To my house colleagues:

I give reverence to my Lord and Savior and I give honor to each one of you.

I would like to give special mention to our house leadership; speaker Craig DeRoche, democratic leader Diane Byrum, majority floor leader Chris Ward, and Michigan Legislative Black Caucus chair, Michael Murphy.

When I was first elected to this great body, there were those who said do not lose your smile and do not allow Lansing to steal your joy.

My joy was tested long before I arrived in Lansing as a state representative.

Each time that my joy was tested, I was reminded of my childhood and those long hot days in Alabama when I picked cotton and worked in the tobacco fields for wages that would have shamed even the coldest opponents of a living wage.

I never dreamed that one day I would become a legislator able to cast a vote for a humane minimum wage. But it happened.

Every time my joy was tested, I remember those terror filled days when I stood by as a child and witnessed domestic violence against my mother and other family members and thought that I could do nothing about it.

I never dreamed that one day I would become a legislator where my vote would have a direct impact on public policy related to combating domestic violence. But it happened.

Every time my joy was tested, I remember those days when I was told, Mary you won't be able to go to college. I never dreamed that one day I would graduate from the University of Michigan. But it happened.

I have been blessed because of my faith and my refusal to give in to dream busters - those that tell us what we can't do. I have been able to achieve in this honorable body because I see the good in all people - no matter what side of the aisle you may sit. I could have allowed my negative experiences to impact my life in a different way, but when I moved to Michigan for a better life I set goals and worked hard to achieve them.

That is why I was able to graduate from the University of Michigan and became the first African American female democratic floor leader. So each time my joy was tested, I was reminded of those prayer meetings on Sunday mornings and Wednesday nights when my grandmother would sing the lord will make a way and amazing grace. Those life experiences help remind me that I got here, not because I am so great, but because of god's grace and mercy.

When I ran for the Detroit charter revision commission in 1993, there were many who asked why I was running. They wondered who had ordained me for such a thing. Some suggested that I not run because I could not win.

To sum this up, I told them that I was stepping out on faith. I received 2 endorsements during that time, Wayne county chairwoman jewel ware and the Detroit news. After serving on the charter commission, I was bitten again by that political bug that is still biting many in this chamber today.

While I was unsuccessful with a couple of other runs, there were always something positive to take away.

I managed to increase my name id and for the first time, I began talking publicly about my experiences in the cotton and tobacco fields of Alabama and the terror I experienced as a child witnessing domestic violence.

I want to thank my political consultant and dear friend, Sam riddle, for convincing me that if I shared my experiences, I just might help someone.

Then, when I ran for state representative in 2000, I experienced the dream busters – again – I was told not to run. I was assured that there were others with political connections and better name id that would surely win.

Again, I said, it's spiritual so I must do this. I experienced many stumbling blocks along the way, but god always had a few rams in the bush for me.

I thank **Lamar Lemmons**, **III** who consistently told me that I could win that race. Lamar thanks for your vision and encouragement.

How did I end up in this thing called politics? I started out as a volunteer for **Representative George Cushingberry**. Cush taught me a lot about campaigning and his family adopted me as a daughter and sister. Thank you Cush.

I am grateful to those who decided to make me the first African American female floor leader. Because of the efforts of **Jack Minore**, **Julie Dennis**, **Gretchen Whitmer**, **Artina Tinsley-Hardman** and **Bill O'Neil** I was elected to that position four years ago. I thank my caucus members from the bottom of my heart for standing by me even in the face of powerful opposition. I would be remiss if I did not mention other influential members of this chamber. **Keith Stallworth**, they call him the mad scientist. **Randy Richardville**, my spiritual brother. Randy always said sure Mary, I'll let your members speak or have a record roll call; we are just going to vote you down.

Virgil Smith (POO) thanks for your unwavering support and your honesty. You were always straight up with me. I also appreciate you for always being there.

Alma Wheeler Smith. You came to this caucus, rolled up your sleeves. Thanks for your hard work, knowledge and wisdom.

Leader Byrum. (Lady Dy) this caucus could not have asked for a more dedicated leader. You were focused and you were on a mission.
