

HOUSE BILL No. 4525

March 22, 2007, Introduced by Rep. Condino and referred to the Committee on Judiciary.

A bill to amend 1972 PA 222, entitled

"An act to provide for an official personal identification card; to provide for its form, issuance and use; to regulate the use and disclosure of information obtained from the card; to prescribe the powers and duties of the secretary of state; to prescribe fees; to prescribe certain penalties for violations; and to provide an appropriation for certain purposes,"

by amending section 1 (MCL 28.291), as amended by 2005 PA 143.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. (1) A person who is a resident of this state may apply
2 to the department of state for an official state personal
3 identification card. Upon application the applicant shall supply a
4 birth certificate attesting to his or her age or other sufficient
5 documents or identification as the secretary of state may require.
6 An application for a state personal identification card shall be

1 made in a manner prescribed by the secretary of state and shall
2 contain the applicant's full name, date of birth, residence
3 address, height, sex, eye color, signature, and, beginning January
4 1, 2007, intent to be an organ donor, and other information
5 required or permitted on the official state personal identification
6 card. The applicant may provide a mailing address if the applicant
7 receives mail at an address different from his or her residence
8 address.

9 (2) THE SECRETARY OF STATE SHALL ACCEPT AS 1 OF THE
10 IDENTIFICATION DOCUMENTS REQUIRED UNDER SUBSECTION (1) AN
11 IDENTIFICATION CARD ISSUED BY THE DEPARTMENT OF CORRECTIONS TO
12 PRISONERS WHO ARE PLACED ON PAROLE OR RELEASED FROM A CORRECTIONAL
13 FACILITY, CONTAINING THE PRISONER'S NAME, PHOTOGRAPH, AND OTHER
14 INFORMATION IDENTIFYING THE PRISONER AS PROVIDED IN SECTION 37(4)
15 OF THE CORRECTIONS CODE OF 1953, 1953 PA 232, MCL 791.237.

16 (3) THE SECRETARY OF STATE SHALL HAVE ELECTRONIC ACCESS TO
17 PRISONER BIOGRAPHY INFORMATION MAINTAINED BY THE DEPARTMENT OF
18 CORRECTIONS FOR THE PURPOSE OF VERIFYING THE IDENTITY OF A PRISONER
19 WHO APPLIES FOR AN OFFICIAL STATE IDENTIFICATION CARD UNDER
20 SUBSECTION (1).

21 (4) ~~(2)~~—The secretary of state shall not issue an official
22 state personal identification card to a person who holds an
23 operator's or chauffeur's license issued under the Michigan vehicle
24 code, 1949 PA 300, MCL 257.1 to 257.923, unless the license has
25 been suspended, revoked, or restricted.
