SUBSTITUTE FOR

HOUSE BILL NO. 5562

(As amended March 5, 2008)

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 81e.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 81E. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, AN
- 2 INDIVIDUAL WHO ASSAULTS OR BATTERS ANOTHER INDIVIDUAL UNDER ANY OF
- 3 THE FOLLOWING CIRCUMSTANCES AND CAUSES ANY BODILY INJURY TO THAT
- 4 OTHER INDIVIDUAL IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT
- 5 FOR NOT MORE THAN [2] YEARS OR A FINE OF NOT MORE THAN \$2,000.00, OR
- 6 BOTH:
- 7 (A) THE OTHER INDIVIDUAL IS IN A LOCATION DESIGNATED IN
- 8 COMPLIANCE WITH STATE OR LOCAL LAW AS AN AREA FOR USE BY PUBLIC
- 9 TRANSIT VEHICLES IN PICKING UP OR DISCHARGING PASSENGERS.
- 10 (B) THE OTHER INDIVIDUAL IS IN A FACILITY OR AREA THAT IS

- 1 OWNED OR OPERATED BY A PUBLIC TRANSIT AUTHORITY AND THAT IS FOR USE
- 2 IN PROVIDING TRANSPORTATION SERVICES TO THE GENERAL PUBLIC,
- 3 INCLUDING A PARKING LOT FOR VISITORS.
- 4 (2) A PERSON WHO VIOLATES THIS SECTION AND BY THAT VIOLATION
- 5 CAUSES A BODILY INJURY REQUIRING MEDICAL ATTENTION OR MEDICAL CARE
- 6 TO AN INDIVIDUAL DESCRIBED IN THIS SECTION IS GUILTY OF A FELONY
- 7 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A FINE OF
- 8 NOT MORE THAN \$5,000.00, OR BOTH.
- 9 (3) A PERSON WHO VIOLATES THIS SECTION AND BY THAT VIOLATION
- 10 CAUSES SERIOUS IMPAIRMENT OF A BODY FUNCTION OF AN INDIVIDUAL
- 11 DESCRIBED IN THIS SECTION IS GUILTY OF A FELONY PUNISHABLE BY
- 12 IMPRISONMENT FOR NOT MORE THAN 10 YEARS OR A FINE OF NOT MORE THAN
- 13 \$10,000.00, OR BOTH.
- 14 (4) A PERSON WHO VIOLATES THIS SECTION AND BY THAT VIOLATION
- 15 CAUSES THE DEATH OF AN INDIVIDUAL DESCRIBED IN THIS SECTION IS
- 16 GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 20
- 17 YEARS OR A FINE OF NOT MORE THAN \$20,000.00, OR BOTH.
- 18 (5) THIS SECTION DOES NOT PROHIBIT AN INDIVIDUAL FROM BEING
- 19 CHARGED WITH, CONVICTED OF, OR PUNISHED FOR ANY OTHER VIOLATION OF
- 20 LAW THAT IS COMMITTED BY THAT INDIVIDUAL WHILE VIOLATING THIS
- 21 SECTION.
- 22 (6) AS USED IN THIS SECTION:
- 23 (A) "PUBLIC TRANSIT AUTHORITY" MEANS AN ENTITY OF A LOCAL UNIT
- 24 OF GOVERNMENT OF THIS STATE OR A COMBINATION OF LOCAL UNITS OF
- 25 GOVERNMENT OF THIS STATE THAT IS AUTHORIZED BY LAW TO PROVIDE
- 26 TRANSPORTATION SERVICES TO THE GENERAL PUBLIC.
- 27 (B) "PUBLIC TRANSIT VEHICLE" MEANS A VEHICLE USED BY A PUBLIC

- 1 TRANSIT AUTHORITY TO PROVIDE TRANSPORTATION SERVICES TO THE GENERAL
- 2 PUBLIC.
- 3 (C) "SERIOUS IMPAIRMENT OF BODY FUNCTION" MEANS THAT TERM AS
- 4 DEFINED IN SECTION 58C OF THE MICHIGAN VEHICLE CODE, 1949 PA 300,
- 5 MCL 257.58C.
- 6 Enacting section 1. This amendatory act takes effect June 1,
- **7** 2008.
- 8 Enacting section 2. This amendatory act does not take effect
- 9 unless House Bill No. 5560 of the 94th Legislature is enacted into
- **10** law.
