SENATE BILL NO. 1374

A bill to amend 2001 PA 63, entitled "History, arts, and libraries act," by amending the title and section 2 (MCL 399.702), section 2 as amended by 2008 PA 85, and by adding section 9.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 TITLE
- 2 An act to create a department of history, arts, and libraries;
- 3 to provide for its administration; and to provide for its powers,
- 4 duties, functions, and responsibilities; AND TO ESTABLISH THE
- 5 MICHIGAN COUNCIL FOR THE ARTS FUND.
- 6 Sec. 2. As used in this act:
- 7 (a) "Council" means the Michigan council for arts and cultural
- 8 affairs established by Executive Order No. 1991-21.

- 1 (b) "Department" means the department of history, arts, and
- 2 libraries created in section 3.
- 3 (c) "Director" means the director of the department.
- 4 (D) "FUND" MEANS THE MICHIGAN COUNCIL FOR THE ARTS FUND
- 5 CREATED IN SECTION 9.
- 6 (E) (d) "Person" means an individual, partnership,
- 7 corporation, association, governmental entity, or other legal
- 8 entity.
- 9 (F) (e)—"Type II transfer" means that term as it is defined in
- 10 section 3 of the executive organization act of 1965, 1965 PA 380,

- 12 SEC. 9. (1) THE MICHIGAN COUNCIL FOR THE ARTS FUND IS CREATED
- 13 IN THE DEPARTMENT. THE FUND SHALL BE ADMINISTERED BY THE
- 14 DEPARTMENT, AND MONEY IN THE FUND SHALL BE EXPENDED ONLY TO FUND
- 15 GRANTS ADMINISTERED BY THE COUNCIL.
- 16 (2) THE DEPARTMENT SHALL CREDIT TO THE FUND ALL AMOUNTS
- 17 APPROPRIATED TO THE FUND UNDER THIS ACT AND ANY MONEY RECEIVED AS
- 18 CONTRIBUTIONS FOR PURPOSES UNDER THIS ACT, INCLUDING MONEY CREDITED
- 19 TO THE FUND PURSUANT TO SECTION 435 OF THE INCOME TAX ACT OF 1967,
- 20 1967 PA 281, MCL 206.435, ANY INTEREST AND EARNINGS ACCRUING FROM
- 21 THE SAVING AND INVESTMENT OF THAT MONEY, AND ANY OTHER
- 22 APPROPRIATIONS, MONEY, OR OTHER THINGS OF VALUE RECEIVED BY THE
- 23 FUND.
- 24 (3) THE STATE TREASURER SHALL DIRECT THE INVESTMENT OF THE
- 25 FUND.
- 26 (4) MONEY APPROPRIATED OR MONEY RECEIVED AS A CONTRIBUTION TO
- 27 THE FUND SHALL BE AVAILABLE FOR DISBURSEMENT UPON APPROPRIATION.

- (5) MONEY IN THE FUND AT THE CLOSE OF THE YEAR SHALL REMAIN IN 1
- 2 THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.
- (6) BY NOVEMBER 1 OF EACH YEAR, THE DEPARTMENT SHALL PROVIDE A 3
- REPORT TO THE SENATE AND HOUSE OF REPRESENTATIVES APPROPRIATIONS
- SUBCOMMITTEES ON HISTORY, ARTS, AND LIBRARIES OF ALL REVENUES TO 5
- AND EXPENDITURES FROM THE FUND. THE REPORT SHALL INCLUDE AN
- ESTIMATED FUND BALANCE FOR THE FISCAL YEAR. 7
- 8 Enacting section 1. This amendatory act does not take effect
- unless Senate Bill No. 1353 of the 94th Legislature is enacted into
- 10 law.
