- 1 Sec. 2110a. (1) If—EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION
- 2 (2), IF uniformly applied to all its insureds, an insurer may
- 3 establish and maintain a premium discount plan utilizing factors in
- 4 addition to those permitted by section 2111 for insurance if the
- 5 plan is consistent with the purposes of this act and reflects
- 6 reasonably anticipated reductions in losses or expenses. This
- 7 section does not affect benefits or obligations required under
 - chapter 31. Nothing in this section authorizes an insurer to offer

- 1 or prohibits an insurer from offering premium discount plans
- 2 concerning any of the following:
- 3 (a) Health care services, health care providers, or health

- 5 (b) Automobile repair providers.
