

HOUSE BILL No. 4321

February 27, 2007, Introduced by Reps. Nitz, Nofs, Stahl, Ball, Proos, Meekhof, Casperson, Caswell, Dean, Stakoe, Gaffney, Rick Jones, Hansen, Marleau and Agema and referred to the Committee on Judiciary.

A bill to amend 1935 PA 59, entitled

"An act to provide for the public safety; to create the Michigan state police, and provide for the organization thereof; to transfer thereto the offices, duties and powers of the state fire marshal, the state oil inspector, the department of the Michigan state police as heretofore organized, and the department of public safety; to create the office of commissioner of the Michigan state police; to provide for an acting commissioner and for the appointment of the officers and members of said department; to prescribe their powers, duties, and immunities; to provide the manner of fixing their compensation; to provide for their removal from office; and to repeal Act No. 26 of the Public Acts of 1919, being sections 556 to 562, inclusive, of the Compiled Laws of 1929, and Act No. 123 of the Public Acts of 1921, as amended, being sections 545 to 555, inclusive, of the Compiled Laws of 1929,"

by amending section 6d (MCL 28.6d), as added by 1982 PA 531.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 6d. (1) The director may appoint officers ~~with limited~~
2 ~~arrest powers~~ for motor carrier enforcement. ~~Such~~ **THOSE** officers
3 shall be officers of the motor carrier enforcement division of the

1 department and shall have all powers conferred upon peace officers.
2 ~~for the purpose of enforcing the general laws of this state as they~~

5 (2) SUBJECT TO SUBSECTION (3), A MOTOR CARRIER ENFORCEMENT
6 OFFICER APPOINTED UNDER THIS SECTION SHALL BE TRAINED BY THE
7 DEPARTMENT TO BE CERTIFIED AND AUTHORIZED TO BE EMPLOYED AS A LAW
8 ENFORCEMENT OFFICER PURSUANT TO THE COMMISSION ON LAW ENFORCEMENT
9 STANDARDS ACT, 1965 PA 203, MCL 28.601 TO 28.616.

10 (3) EACH MOTOR CARRIER ENFORCEMENT OFFICER WHO IS NOT
11 CERTIFIED ON THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT AMENDED
12 THIS SECTION SHALL BE PROVIDED WITH SUFFICIENT ADDITIONAL TRAINING
13 TO BE CERTIFIED AND AUTHORIZED TO BE EMPLOYED AS A LAW ENFORCEMENT
14 OFFICER PURSUANT TO THE COMMISSION ON LAW ENFORCEMENT STANDARDS
15 ACT, 1965 PA 203, MCL 28.601 TO 28.616, WITHIN 1 YEAR AFTER THAT
16 DATE.
