## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 225. (1) SUBJECT TO SUBSECTION (3), A PERSON SHALL NOT
- 2 CHANGE, ALTER, REMOVE, OR OBLITERATE ANY COLORATION OR MARKINGS
- 3 THAT ARE REQUIRED FOR AN IMITATION FIREARM BY ANY APPLICABLE STATE
- 4 OR FEDERAL LAW IN ANY WAY THAT MAKES AN IMITATION FIREARM LOOK MORE
- 5 LIKE A FIREARM. A PERSON THAT VIOLATES THIS SUBSECTION IS GUILTY OF
- 6 A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS
- OR A FINE OF NOT MORE THAN \$500.00, OR BOTH.
- 8 (2) AN INDIVIDUAL SHALL NOT KNOWINGLY POINT, DISPLAY, OR USE
- 9 AN IMITATION FIREARM WITH THE PURPOSE OF INTIMIDATING, THREATENING,
- 10 OR ATTEMPTING TO PUT AN INDIVIDUAL IN FEAR OF BODILY INJURY OR FOR

- 1 ANY UNLAWFUL PURPOSE. AN INDIVIDUAL WHO VIOLATES THIS SUBSECTION IS

- 10 MANUFACTURED EXCLUSIVELY TO PROPEL BBS THAT DO NOT EXCEED .177
- 11 CALIBER BY A SPRING OR BY GAS OR AIR.
- 12 (B) "FIREARM" MEANS THAT TERM AS DEFINED IN SECTION 222.
- 13 (C) "IMITATION FIREARM" MEANS A BB GUN, TOY GUN, REPLICA OF A
- 14 FIREARM, OR OTHER DEVICE THAT IS SO SUBSTANTIALLY SIMILAR IN
- 15 COLORATION AND OVERALL APPEARANCE TO AN EXISTING FIREARM AS TO LEAD
- 16 A REASONABLE PERSON TO PERCEIVE THAT THE DEVICE IS A FIREARM.
