HOUSE BILL No. 5325

October 18, 2007, Introduced by Reps. Scott, Johnson, Lemmons, Polidori, Constan, Condino, Farrah, Virgil Smith, Wojno, Simpson, Young, Gaffney and Cushingberry and referred to the Committee on Energy and Technology.

A bill to amend 1939 PA 3, entitled

"An act to provide for the regulation and control of public and certain private utilities and other services affected with a public interest within this state; to provide for alternative energy suppliers; to provide for licensing; to include municipally owned utilities and other providers of energy under certain provisions of this act; to create a public service commission and to prescribe and define its powers and duties; to abolish the Michigan public utilities commission and to confer the powers and duties vested by law on the public service commission; to provide for the continuance, transfer, and completion of certain matters and proceedings; to abolish automatic adjustment clauses; to prohibit certain rate increases without notice and hearing; to qualify residential energy conservation programs permitted under state law for certain federal exemption; to create a fund; to provide for a restructuring of the manner in which energy is provided in this state; to encourage the utilization of resource recovery facilities; to prohibit certain acts and practices of providers of energy; to allow for the securitization of stranded costs; to reduce rates; to provide for appeals; to provide appropriations; to declare the effect and purpose of this act; to prescribe remedies and penalties; and to repeal acts and parts of acts,"

(MCL 460.1 to 460.10cc) by adding section 9d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- SEC. 9D. (1) A SERVICE PROVIDER SHALL NOT DISCONTINUE SERVICE
- TO A QUALIFYING CUSTOMER WHO HAS FILED AN APPLICATION WITH A

- 17 (C) PROVIDE QUALIFYING CUSTOMERS WITH ACCESS TO EXISTING

- 19 (4) AS USED IN THIS SECTION:
- 20 (A) "QUALIFYING CUSTOMER" MEANS A CUSTOMER WHO DEMONSTRATES
- 21 EACH OF THE FOLLOWING:
- 22 (i) THE CUSTOMER HAS A SERIOUS MEDICAL CONDITION WHICH REQUIRES
- 23 ELECTRIC OR GAS SERVICE, INCLUDING, BUT NOT LIMITED TO, A MEDICAL
- 24 CONDITION REQUIRING DIALYSIS TREATMENT.
- 25 (ii) THE CUSTOMER HAS PROVIDED VERIFICATION OF THE SERIOUS
- 26 MEDICAL CONDITION TO THE SERVICE PROVIDER.
- 27 (B) "SERVICE PROVIDER" MEANS A PROVIDER OF ELECTRIC OR NATURAL
