A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 81e.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 81E. (1) AN INDIVIDUAL WHO ASSAULTS AND BATTERS ANOTHER
- 2 INDIVIDUAL UNDER ANY OF THE FOLLOWING CIRCUMSTANCES AND CAUSES ANY
- 3 PHYSICAL INJURY TO THAT OTHER INDIVIDUAL IS GUILTY OF A FELONY
- 4 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A FINE OF
- 5 NOT MORE THAN \$2,000.00, OR BOTH:
- 6 (A) THE OTHER INDIVIDUAL IS IN A LOCATION DESIGNATED IN
- 7 COMPLIANCE WITH STATE OR LOCAL LAW AS AN AREA FOR USE BY PUBLIC
- 8 TRANSIT VEHICLES IN PICKING UP OR DISCHARGING PASSENGERS.
  - (B) THE OTHER INDIVIDUAL IS IN A FACILITY OR AREA THAT IS

- 1 OWNED OR OPERATED BY A PUBLIC TRANSIT AUTHORITY AND THAT IS FOR USE
