

HOUSE BILL No. 5656

January 22, 2008, Introduced by Reps. Agema, Palmer, Pavlov, Meltzer, Elsenheimer, Knollenberg, Acciavatti, Stahl, Opsommer, Amos, Sheen, Booher, Nofs, Moolenaar, Walker, Steil, Brandenburg, Pastor and Rick Jones and referred to the Committee on Oversight and Investigations.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16bb of chapter XVII (MCL 777.16bb), as added
by 2007 PA 20.
