## **HOUSE BILL No. 5785**

A bill to amend 1996 PA 376, entitled

"Michigan renaissance zone act,"

by amending sections 15 and 16 (MCL 125.2695 and 125.2696) and by adding sections 8g and 8h.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 8G. BEGINNING JULY 1, 2008, WHEN DESIGNATING A
- 2 RENAISSANCE ZONE UNDER SECTION 8A(2), 8C, 8D, 8E, OR 8F, IF ALL
- 3 OTHER CONSIDERATIONS ARE EQUAL, THE BOARD OR THE MICHIGAN STRATEGIC
- 4 FUND, AS APPLICABLE, SHALL GIVE PREFERENCE TO AN APPLICANT FOR
- 5 RENAISSANCE ZONE STATUS IF THE APPLICANT AGREES, IN WRITING, TO DO
- 6 ALL OF THE FOLLOWING:
- 7 (A) HIRE ONLY RESIDENTS OF THIS STATE TO OPERATE A FACILITY IN
  - THE RENAISSANCE ZONE, UNLESS THE BOARD OR THE MICHIGAN STRATEGIC
