

# HOUSE BILL No. 6201

June 4, 2008, Introduced by Reps. Angerer, Simpson, Stahl, Gillard, Lemmons, Mayes, Corriveau, Espinoza, Hammel, Spade, Brandenburg, Pastor, Rick Jones, Agema, Sheltroun, Nofs, Moolenaar, Caul, Opsommer, Bennett and Young and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled  
"Public health code,"  
by amending sections 16423 and 16431 (MCL 333.16423 and 333.16431),  
section 16431 as amended by 1994 PA 234.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Sec. 16423. (1) The board shall promulgate rules to establish  
2 criteria for the approval of analytical instruments, **IMAGING**  
3 **TECHNOLOGY**, and adjustment apparatus to be used for the purpose of  
4 examining **AND TREATING** patients ~~in locating spinal~~ **FOR** subluxations  
5 and misalignments ~~of the human spine~~ **THAT PRODUCE NERVE**  
6 **INTERFERENCE OR JOINT DYSFUNCTION**. The criteria established shall  
7 be substantially equivalent to nationally recognized standards in  
8 the profession for the use and operation of the instruments **OR**  
9 **APPARATUS**. The board may approve types and makes of analytical

1 instruments **AND IMAGING TECHNOLOGY** that meet these criteria.

2 (2) An individual shall not use analytical instruments,  
3 **IMAGING TECHNOLOGY**, or adjustment apparatus ~~which does~~ **THAT DO** not  
4 meet nationally recognized standards or ~~which is~~ **THAT ARE** not  
5 approved by the board.

6 Sec. 16431. (1) Notwithstanding the requirements of part 161,  
7 the board may require a licensee seeking renewal of a license to  
8 furnish the board with satisfactory evidence that during the 2  
9 years immediately preceding the application for renewal the  
10 applicant has attended not less than two 2-day educational  
11 conferences approved by the board, in subjects related to the  
12 practice of chiropractic and designed to further educate licensees.

13 (2) As required under section 16204, the board shall  
14 promulgate rules requiring each applicant for license renewal to  
15 complete as part of the educational conferences required under  
16 subsection (1) an appropriate number of hours or courses in pain  
17 and symptom management.

18 (3) **THE BOARD SHALL PROMULGATE RULES REQUIRING EACH APPLICANT**  
19 **FOR LICENSE RENEWAL TO COMPLETE AS PART OF THE EDUCATIONAL**  
20 **CONFERENCES REQUIRED UNDER SUBSECTION (1) AN APPROPRIATE NUMBER OF**  
21 **HOURS OR COURSES IN NEW IMAGING TECHNOLOGY AND EXTRASPINAL**  
22 **TREATMENT.**

23 Enacting section 1. This amendatory act does not take effect  
24 unless House Bill No. 5759 of the 94th Legislature is enacted into  
25 law.
