

SENATE BILL No. 1150

EXECUTIVE BUDGET BILL

February 28, 2008, Introduced by Senators BRATER and SWITALSKI and referred to the Committee on Appropriations.

A bill to make appropriations for the department of natural resources for the fiscal year ending September 30, 2009 to provide for the expenditure of those appropriations; to create funds and accounts; to require reports; to prescribe certain powers and duties of certain state agencies and officials; to authorize certain transfers by certain state agencies; and to provide for the disposition of fees and other income received by the various state agencies.

PART 2

PROVISIONS CONCERNING APPROPRIATIONS

GENERAL SECTIONS

Sec. 201. Pursuant to section 30 of article IX of the state constitution of 1963, total state spending from state resources under part 1 for fiscal year 2008-2009 is \$230,012,400.00 and state spending from state resources to be paid to local units of government for fiscal year 2008-2009 is \$18,846,100.00. The itemized statement below identifies appropriations from which spending to local units of government will occur:

Sec. 202. The appropriations authorized under this bill are subject to the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

Sec. 203. As used in this bill:

1 (a) "Commission" means the commission of natural resources.

2 (b) "DAG" means the United States department of agriculture.

3 (c) "Department" means the department of natural resources.

4 (d) "DHS" means the United States department of homeland
5 security.

6 (e) "Director" means the director of the department of natural
7 resources.

8 (f) "DOC" means the United States department of commerce.

9 (g) "DOE" means the United States department of energy.

10 (h) "DOI" means the United States department of interior.

11 (i) "DOT" means the United States department of
12 transportation.

13 (j) "EPA" means the United States environmental protection
14 agency.

15 (k) "FTE" means full-time equated.

16 (l) "IDG" means interdepartmental grant.

17 Sec. 204. The civil service commission shall bill departments
18 and agencies at the end of the first fiscal quarter for the 1%
19 charge authorized by section 5 of article XI of the state
20 constitution of 1963. Payments shall be made for the total amount
21 of the billing by the end of the second fiscal quarter.

22 Sec. 205. (1) A hiring freeze is imposed on the state
23 classified civil service. State departments and agencies are
24 prohibited from hiring any new full-time state classified civil
25 service employees and prohibited from filling any vacant state
26 classified civil service positions. This hiring freeze does not
27 apply to internal transfers of classified employees from 1 position

1 to another within a department.

2 (2) The state budget director may grant exceptions to this
3 hiring freeze when the state budget director believes that the
4 hiring freeze will result in rendering a state department or agency
5 unable to deliver basic services, cause loss of revenue to the
6 state, result in the inability of the state to receive federal
7 funds, or necessitate additional expenditures that exceed any
8 savings from maintaining a vacancy. The state budget director shall
9 report quarterly to the chairpersons of the senate and house of
10 representatives standing committees on appropriations the number of
11 exceptions to the hiring freeze approved during the previous
12 quarter and the reasons to justify the exception.

13 Sec. 206. The department shall use the Internet to fulfill the
14 reporting requirements of this bill. This requirement may include
15 transmission of reports via electronic mail to the recipients
16 identified for each reporting requirement, or it may include
17 placement of reports on an Internet or Intranet site.

18 Sec. 207. Funds appropriated in part 1 shall not be used for
19 the purchase of foreign goods or services, or both, if
20 competitively priced and of comparable quality American goods or
21 services, or both, are available. Preference shall be given to
22 goods or services, or both, manufactured or provided by Michigan
23 businesses, if they are competitively priced and of comparable
24 quality. In addition, preference shall be given to goods or
25 services, or both, that are manufactured or provided by Michigan
26 businesses owned and operated by veterans, if they are
27 competitively priced and of comparable quality.

1 Sec. 208. The director shall take all reasonable steps to
2 ensure businesses in deprived and depressed communities compete for
3 and perform contracts to provide services or supplies, or both. The
4 director shall strongly encourage firms with which the department
5 contracts to subcontract with certified businesses in depressed and
6 deprived communities for services, supplies, or both.

7 Sec. 209. From the funds appropriated in part 1 for
8 information technology, departments and agencies shall pay user
9 fees to the department of information technology for technology-
10 related services and projects. Such user fees shall be subject to
11 provisions of an interagency agreement between the departments and
12 agencies and the department of information technology.

13 Sec. 210. Amounts appropriated in part 1 for information
14 technology may be designated as work projects and carried forward
15 to support technology projects under the direction of the
16 department of information technology. Funds designated in this
17 manner are not available for expenditure until approved as work
18 projects under section 451a of the management and budget act, 1984
19 PA 431, MCL 18.1451a.

20 Sec. 211. (1) Due to the current budgetary problems in this
21 state, out-of-state travel for the fiscal year ending September 30,
22 2009 shall be limited to situations in which 1 or more of the
23 following conditions apply:

24 (a) The travel is required by legal mandate or court order or
25 for law enforcement purposes.

26 (b) The travel is necessary to protect the health or safety of
27 Michigan citizens or visitors or to assist other states in similar

1 circumstances.

2 (c) The travel is necessary to produce budgetary savings or to
3 increase state revenues, including protecting existing federal
4 funds or securing additional federal funds.

5 (d) The travel is necessary to comply with federal
6 requirements.

7 (e) The travel is necessary to secure specialized training for
8 staff that is not available within this state.

9 (f) The travel is financed entirely by federal or nonstate
10 funds.

11 (2) If out-of-state travel is necessary but does not meet 1 or
12 more of the conditions in subsection (1), the state budget director
13 may grant an exception to allow the travel. Any exceptions granted
14 by the state budget director shall be reported on a monthly basis
15 to the senate and house of representatives standing committees on
16 appropriations.

17 (3) Not later than January 1 of each year, each department
18 shall prepare a travel report listing all travel by classified and
19 unclassified employees outside this state in the immediately
20 preceding fiscal year that was funded in whole or in part with
21 funds appropriated in the department's budget. The report shall be
22 submitted to the senate and house of representatives standing
23 committees on appropriations, the senate and house fiscal agencies,
24 and the state budget director. The report shall include the
25 following information:

26 (a) The name of each person receiving reimbursement for travel
27 outside this state or whose travel costs were paid by this state.

1 (b) The destination of each travel occurrence.

2 (c) The dates of each travel occurrence.

3 (d) A brief statement of the reason for each travel
4 occurrence.

5 (e) The transportation and related costs of each travel
6 occurrence, including the proportion funded with state general
7 fund/general purpose revenues, the proportion funded with state
8 restricted revenues, the proportion funded with federal revenues,
9 and the proportion funded with other revenues.

10 (f) A total of all out-of-state travel funded for the
11 immediately preceding fiscal year.

12 Sec. 212. Funds appropriated in part 1 shall not be used by a
13 principal executive department, state agency, or authority to hire
14 a person to provide legal services that are the responsibility of
15 the attorney general. This prohibition does not apply to legal
16 services for bonding activities and for those activities that the
17 attorney general authorizes.

18 Sec. 213. (1) In addition to the funds appropriated in part 1,
19 there is appropriated an amount not to exceed \$3,000,000.00 for
20 federal contingency funds. These funds are not available for
21 expenditure until they have been transferred to another line item
22 in this bill under section 393(2) of the management and budget act,
23 1984 PA 431, MCL 18.1393.

24 (2) In addition to the funds appropriated in part 1, there is
25 appropriated an amount not to exceed \$5,000,000.00 for state
26 restricted contingency funds. These funds are not available for
27 expenditure until they have been transferred to another line item

1 in this bill under section 393(2) of the management and budget act,
2 1984 PA 431, MCL 18.1393.

3 (3) In addition to the funds appropriated in part 1, there is
4 appropriated an amount not to exceed \$100,000.00 for local
5 contingency funds. These funds are not available for expenditure
6 until they have been transferred to another line item in this bill
7 under section 393(2) of the management and budget act, 1984 PA 431
8 MCL 18.1393.

9 (4) In addition to the funds appropriated in part 1, there is
10 appropriated an amount not to exceed \$1,000,000.00 for private
11 contingency funds. These funds are not available for expenditure
12 until they have been transferred to another line item in this bill
13 under section 393(2) of the management and budget act, 1984 PA 431,
14 MCL 18.1393.

15 Sec. 214. Pursuant to section 43703(3) of the natural
16 resources and environmental protection act, 1994 PA 451, MCL
17 324.43703, there is appropriated from the game and fish protection
18 trust fund to the game and fish protection account of the Michigan
19 conservation and recreation legacy fund, \$6,000,000.00 for the
20 fiscal year ending September 30, 2009.

21 Sec. 215. Appropriations of state-restricted game and fish
22 protection funds have been made to the following departments and

4 **ADMINISTRATIVE SERVICES**

5 Sec. 401. The department may charge the appropriations
6 contained in part 1, including all special maintenance and capital
7 projects appropriated for the fiscal year ending September 30,
8 2009, for engineering services provided, a standard percentage fee
9 to recover actual costs. The department may use the revenue derived
10 to support the engineering services charges provided for in part 1.

11 Sec. 402. The department may charge land acquisition projects
12 appropriated for the fiscal year ending September 30, 2009, and for
13 prior fiscal years, a standard percentage fee to recover actual
14 costs, and may use the revenue derived to support the land
15 acquisition service charges provided for in part 1.

16 Sec. 403. The department may charge both application fees and
17 transaction fees related to the exchange or sale of state-owned
18 land or rights in land authorized by part 21 of the natural
19 resources and environmental protection act, 1994 PA 451, MCL
20 324.2101 to 324.2162. The fees shall be set by the director at a
21 rate which allows the department to recover its costs for providing
22 these services.

23 **WILDLIFE MANAGEMENT**

24 Sec. 501. From the funds appropriated in part 1, the
25 department shall submit quarterly reports to the state budget

1 director, the senate and house appropriations subcommittees on
2 natural resources, and the senate and house fiscal agencies that
3 provide detail about enforcement actions taken to eradicate bovine
4 tuberculosis, the number of infected deer found, new science it is
5 working on to detect bovine tuberculosis, and other relevant
6 information about the department's efforts to address the presence
7 of bovine tuberculosis in the state.

8 **FISHERIES MANAGEMENT**

9 Sec. 601. (1) From the appropriation in part 1 for aquatic
10 resource mitigation, not more than \$758,000.00 shall be allocated
11 for grants to watershed councils, resource development councils,
12 soil conservation districts, local governmental units, and other
13 nonprofit organizations for stream habitat stabilization and soil
14 erosion control.

15 (2) The fisheries division of the department shall develop
16 priority and cost estimates for all recommended projects.

17 **PARKS AND RECREATION**

18 Sec. 701. Pursuant to section 1902(2) of the natural resources
19 and environmental protection act, 1994 PA 451, MCL 324.1902, there
20 is appropriated from the Michigan natural resources trust fund to
21 the Michigan state parks endowment fund an amount not to exceed
22 \$10,000,000.00 for the fiscal year ending September 30, 2009.

23 **FOREST, MINERAL, AND FIRE MANAGEMENT**

24 Sec. 801. In addition to the funds appropriated in part 1,

1 \$350,000.00 is appropriated to cover costs related to any declared
2 emergency involving the collapse of any abandoned mine shaft
3 located on state land. This appropriation shall not be expended
4 unless the state budget director recommends the expenditure and the
5 department notifies the house and senate committees on
6 appropriations.

7 Sec. 802. In addition to the money appropriated in this bill,
8 the department may receive and expend money from federal sources
9 for the purpose of providing response to wildfires as required by a
10 compact with the federal government. If additional expenditure
11 authorization is required, the department shall notify the state
12 budget office that expenditure under this section is required. The
13 department shall notify the house and senate appropriations
14 subcommittees on natural resources and the house and senate fiscal
15 agencies of the expenditures under this section by November 1,
16 2009.

17 GRANTS

18 Sec. 1101. Federal pass-through funds to local institutions
19 and governments that are received in amounts in addition to those
20 included in part 1 for grants to communities - federal oil, gas,
21 and timber payments and that do not require additional state
22 matching funds are appropriated for the purposes intended. By
23 November 30, 2008, the department shall report to the senate and
24 house appropriations subcommittees on natural resources, the senate
25 and house fiscal agencies, and the state budget director on all
26 amounts appropriated under this section during the fiscal year

1 ending September 30, 2008.
