by amending the title and section 1108 (MCL 700.1108), and by adding sections 5109 and 5110.

- 9 (B) (a) "Ward" means an individual for whom a guardian is
- 10 appointed.
- 11 (C) (b) "Will" includes, but is not limited to, a codicil and
- 12 a testamentary instrument that appoints a personal representative,
- 13 revokes or revises another will, nominates a quardian, or expressly
- 14 excludes or limits the right of an individual or class to succeed
- 15 to the decedent's property that is passing by intestate succession.
- 16 SEC. 5109. (1) A POWER OF ATTORNEY MADE BY A PRINCIPAL WHO IS
- 17 60 YEARS OF AGE OR OLDER OR WHO IS A VULNERABLE ADULT SHALL BE
- 18 DEPOSITED BY THE PRINCIPAL, OR BY A PERSON FOR HIM OR HER, WITH THE
- 19 COURT IN THE COUNTY WHERE THE PRINCIPAL RESIDES.
- 20 (2) A POWER OF ATTORNEY DEPOSITED UNDER THIS SECTION SHALL BE
- 21 ENCLOSED IN A SEALED WRAPPER ON WHICH IS PRINTED ALL OF THE
- 22 FOLLOWING:
- 23 (A) THE PRINCIPAL'S NAME, PLACE OF RESIDENCE, AND SOCIAL
- 24 SECURITY NUMBER OR STATE OF MICHIGAN DRIVER LICENSE NUMBER.
- 25 (B) THE NAME, ADDRESS, AND TELEPHONE NUMBER OF THE PERSON
- 26 DESIGNATED AS AGENT IN THE POWER OF ATTORNEY.

- 2 (3) A COURT SHALL RECEIVE AND SAFELY KEEP A POWER OF ATTORNEY
- 3 DELIVERED UNDER THIS SECTION AND SHALL GIVE A CERTIFICATE OF THE
- 4 DEPOSIT. FOR THIS SERVICE, THE COURT SHALL CHARGE AND COLLECT A FEE
- 5 OF \$35.00, WHICH SHALL BE DEPOSITED IN THE VULNERABLE ADULT

- 7 (4) EXCEPT AS ORDERED BY THE COURT, A POWER OF ATTORNEY

- 10 AUTHORIZED BY THE PRINCIPAL OR AGENT IN WRITING THAT IS PROVED BY
- 11 THE OATH OF A SUBSCRIBING WITNESS.
- 12 SEC. 5110. (1) THE VULNERABLE ADULT PROTECTION FUND IS CREATED
- 13 WITHIN THE STATE TREASURY.
- 14 (2) THE STATE TREASURER MAY RECEIVE FEES COLLECTED UNDER
- 15 SECTION 5109 AND MONEY OR OTHER ASSETS FROM ANY OTHER SOURCE FOR
- 16 DEPOSIT INTO THE FUND. THE STATE TREASURER SHALL DIRECT THE
- 17 INVESTMENT OF THE FUND. THE STATE TREASURER SHALL CREDIT TO THE
- 18 FUND INTEREST AND EARNINGS FROM FUND INVESTMENTS.
- 19 (3) MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR SHALL
- 20 REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.
