A bill to amend 1980 PA 307, entitled "Savings and loan act of 1980,"

(MCL 491.102 to 491.1202) by adding section 629.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 629. (1) IF 1 OR MORE CUSTOMERS APPLY TO ESTABLISH A
- 2 JOINT ACCOUNT AT AN ASSOCIATION, THE ASSOCIATION SHALL DO ALL OF
- 3 THE FOLLOWING BEFORE OPENING THE ACCOUNT:
- 4 (A) PROVIDE EACH JOINT ACCOUNT HOLDER WITH THE FOLLOWING
- 5 DISCLOSURE IN WRITING:
- 6 "A JOINT ACCOUNT MEANS THAT EACH ACCOUNT HOLDER IS THE OWNER
- 7 OF THE MONEY IN THIS ACCOUNT. THIS MEANS THAT YOU AND EACH OF THE
- 8 OTHER ACCOUNT HOLDERS HAVE THE AUTHORITY TO DEPOSIT OR WITHDRAW
 - MONEY FROM THIS ACCOUNT AT ANY TIME.

- 1 IF THAT IS NOT YOUR INTENTION, YOU SHOULD NOT OPEN THIS

- 3 IF IT IS YOUR INTENTION THAT THE OTHER ACCOUNT HOLDER OR

- 12 (B) REQUIRE THAT EACH JOINT ACCOUNT HOLDER SIGN AND DELIVER TO
- 13 THE ASSOCIATION A WRITTEN ACKNOWLEDGMENT THAT THE ACCOUNT HOLDER
- 14 HAS READ AND UNDERSTANDS THE DISCLOSURE DESCRIBED IN SUBDIVISION
- 15 (A).
- 16 (2) AN ASSOCIATION MAY INCLUDE THE DISCLOSURE AND
- 17 ACKNOWLEDGMENT DESCRIBED IN SUBSECTION (1) ON OR WITH ANY SIGNATURE
- 18 CARD REQUIRED BY THE ASSOCIATION FROM THE JOINT ACCOUNT HOLDERS IN
- 19 CONNECTION WITH AN ACCOUNT.
