## **HOUSE BILL No. 6386**

August 19, 2010, Introduced by Reps. Tyler, Bolger, Lahti, Lindberg, Wayne Schmidt, Ball, Hansen, Horn, Booher, Meekhof, Denby, Kowall, Pearce, Crawford and Lund and referred to the Committee on Tourism, Outdoor Recreation and Natural Resources.

A bill to amend 2000 PA 190, entitled "Privately owned cervidae producers marketing act," by amending section 5 (MCL 287.955), as amended by 2006 PA 561.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 5. (1) A person shall not possess cervidae or engage in a 2 cervidae livestock operation unless he or she obtains from the 3 department a cervidae livestock facility registration or unless otherwise exempt by rule or law. If the activity in which the 4 5 cervidae livestock facility is engaged is required to be regulated 6 under any other act, registration under this act does not exempt 7 the person or cervidae livestock facility from requirements imposed under any local, state, or federal regulation. Zoos accredited under the American zoological association or other accreditations 10 or standards determined appropriate by and acceptable to the

- 14 (3) Until July 1, 2008, a cervidae livestock facility
- 15 registered prior to the effective date of the amendatory act that
- 16 added this subsection must comply with the facility standards
- 17 contained in "Operational Standards for Registered Privately Owned
- 18 Cervid Facilities", published by the Michigan department of
- 19 agriculture, (May 2000). A cervidae livestock facility in existence
- 20 on or before the effective date of the amendatory act that added
- 21 this subsection DECEMBER 29, 2006 shall be in compliance with the
- 22 facility standards by July 1, 2008, which are contained in
- 23 "Operational Standards for Registered Privately Owned Cervidae
- 24 Facilities" published by the Michigan department of natural
- 25 resources, (revised December 2005), adopted by the Michigan
