SENATE BILL No. 375

March 12, 2009, Introduced by Senators JELINEK, VAN WOERKOM, GEORGE, BIRKHOLZ and CROPSEY and referred to the Committee on Local, Urban and State Affairs.

A bill to amend 1990 PA 345, entitled

"State survey and remonumentation act,"

by amending section 12 (MCL 54.272), as amended by 2002 PA 489.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 12. (1) Money in the fund shall be used by the commission for the following purposes:
 - (a) Annual grants to the various counties to implement their county plans, excluding the perpetual monument maintenance plan described in section 8(2)(d).
 - (b) Annual grants to 2 or more counties to implement their multicounty plan, excluding the perpetual monument maintenance plan described in section 8(2)(d).

- 3 (d) An annual grant to each county that has a county plan or
