A bill to amend 1994 PA 295, entitled "Sex offenders registration act,"

(MCL 28.721 to 28.736) by adding section 5d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 5D. (1) AN INDIVIDUAL WHO IS REQUIRED TO REGISTER UNDER
- 2 THIS ACT SHALL NOT RESIDE AT THE SAME ADDRESS, IN THE SAME
- 3 CONDOMINIUM UNIT OR APARTMENT UNIT, OR IN THE SAME CONDOMINIUM
- 4 COMPLEX OR APARTMENT COMPLEX WITH ANOTHER INDIVIDUAL WHO IS NOT HIS
 - OR HER SPOUSE OR CHILD WHOM HE OR SHE KNOWS OR HAS REASON TO KNOW
 - IS REQUIRED TO REGISTER UNDER THIS ACT.
 - (2) SUBSECTION (1) DOES NOT APPLY TO ANY OF THE FOLLOWING:
- (A) AN INDIVIDUAL WHO WAS RESIDING AT THAT ADDRESS,

- 13 COMPLEX OR APARTMENT COMPLEX IN VIOLATION OF THIS SECTION HAS 30

- 15 SHE IS RESPONSIBLE FOR A CRIMINAL VIOLATION OF THIS SECTION.
