PART 2  
PROVISIONS CONCERNING APPROPRIATIONS  
FOR FISCAL YEAR 2012-2013

GENERAL SECTIONS

Sec. 201. Pursuant to section 30 of article IX of the state constitution of 1963, total state spending from state resources under part 1 for the fiscal year ending September 30, 2013 is \$71,924,800.00 and state spending from state resources to be paid to local units of government for the fiscal year ending September 30, 2013 is \$5,445,700.00. The itemized statement below identifies appropriations from which spending to local units of government will occur:

DEPARTMENT OF EDUCATION

State aid to libraries.....	\$5,445,700

Sec. 202. The appropriations authorized under this act are subject to the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

Sec. 203. As used in this article:

(a) "Department" means the Michigan department of education.

(b) "District" means a local school district as defined in section 6 of the revised school code, 1976 PA 451, MCL 380.6, or a public school academy as defined in section 5 of the revised school code, 1976 PA 451, MCL 380.5.

(c) "FTE" means full-time equated.

1 (d) "IMLS" means institute of museum and library services.

2 Sec. 204. The civil service commission shall bill departments  
3 and agencies at the end of the first fiscal quarter for the charges  
4 authorized by section 5 of article XI of the state constitution of  
5 1963. Payments shall be made for the total amount of the billing by  
6 the end of the second fiscal quarter.

7 Sec. 205. Unless otherwise specified, the departments shall use  
8 the Internet to fulfill the reporting requirements of this act. This  
9 requirement may include transmission of reports via electronic mail  
10 to the recipients identified for each reporting requirement, or it  
11 may include placement of reports on an Internet or Intranet site.

12 Sec. 206. The department shall provide through the Internet the  
13 state board of education agenda and all supporting documents, and  
14 shall notify the state budget director and the senate and house  
15 fiscal agencies that the agenda and supporting documents are  
16 available on the Internet, at the time the agenda and supporting  
17 documents are provided to state board of education members.

18 Sec. 207. (1) The department shall maintain a searchable  
19 website accessible by the public at no cost that includes, but is not  
20 limited to, all of the following:

21 (a) Fiscal year-to-date expenditures by category.

22 (b) Fiscal year-to-date expenditures by appropriation unit.

23 (c) Fiscal year-to-date payments to a selected vendor,  
24 including the vendor name, payment date, payment amount, and payment  
25 description.

26 (d) The number of active department employees by job  
27 classification.

1 (e) Job specifications and wage rates.

2 (2) The department may develop and operate its own website to  
3 provide this information or may reference the state's central  
4 transparency website as the source for this information.

5 Sec. 208. The department shall require all public school  
6 districts to maintain complete records within the personnel file of a  
7 teacher or school employee of any disciplinary actions taken by the  
8 local school board against the teacher or employee for sexual  
9 misconduct. The records shall not be destroyed or removed from the  
10 teacher's or employee's personnel file except as required by a court  
11 order.

12 Sec. 209. From the funds appropriated in part 1 for information  
13 technology, departments and agencies shall pay user fees to the  
14 department of technology, management, and budget for technology-  
15 related services and projects. Such user fees shall be subject to  
16 provisions of an interagency agreement between the departments and  
17 agencies and the department of technology, management, and budget.

18 Sec. 210. Amounts appropriated in part 1 for information  
19 technology may be designated as work projects and carried forward to  
20 support technology projects under the direction of the department of  
21 technology, management, and budget. Funds designated in this manner  
22 are not available for expenditure until approved as work projects  
23 under section 451a of the management and budget act, 1984 PA 431, MCL  
24 18.1451a.

25 Sec. 211. Before publishing a list of schools or districts  
26 determined to have failed to make adequate yearly progress as  
27 required by the no child left behind act of 2001, Public Law 107-110,

1 the department shall allow a school or district to appeal that  
2 determination. The department shall consider and act upon the appeal  
3 within 30 days after it is submitted and shall not publish the list  
4 until after all appeals have been considered and decided.

5       Sec. 212. Funds appropriated in part 1 shall not be used for  
6 the purchase of foreign goods or services, or both, if competitively  
7 priced and comparable quality American goods or services, or both,  
8 are available. Preference shall be given to goods or services, or  
9 both, manufactured or provided by Michigan businesses if they are  
10 competitively priced and of comparable quality. In addition,  
11 preference should be given to goods or services, or both,  
12 manufactured or provided by Michigan businesses owned and operated by  
13 veterans if they are competitively priced and of comparable quality.

14       Sec. 214. (1) Due to the current budgetary problems in this  
15 state, out-of-state travel for the fiscal year ending September 30,  
16 2013 shall be limited to situations in which 1 or more of the  
17 following conditions apply:

18       (a) The travel is required by legal mandate or court order or  
19 for law enforcement purposes.

20       (b) The travel is necessary to protect the health or safety of  
21 Michigan citizens or visitors or to assist other states in similar  
22 circumstances.

23       (c) The travel is necessary to produce budgetary savings or to  
24 increase state revenues, including protecting existing federal funds  
25 or securing additional federal funds.

26       (d) The travel is necessary to comply with federal  
27 requirements.

1 (e) The travel is necessary to secure specialized training for  
2 staff that is not available within this state.

3 (f) The travel is financed entirely by federal or nonstate  
4 funds.

5 (2) Not later than January 1 of each year, each department  
6 shall prepare a travel report listing all travel by classified and  
7 unclassified employees outside this state in the immediately  
8 preceding fiscal year that was funded in whole or in part with funds  
9 appropriated in the department's budget. The report shall be  
10 submitted to the house and senate standing committees on  
11 appropriations, the house and senate fiscal agencies, and the state  
12 budget director. The report shall include the following information:

13 (a) The name of each person receiving reimbursement for travel  
14 outside this state or whose travel costs were paid by this state.

15 (b) The destination of each travel occurrence.

16 (c) The dates of each travel occurrence.

17 (d) A brief statement of the reason for each travel occurrence.

18 (e) The transportation and related costs of each travel  
19 occurrence, including the proportion funded with state general  
20 fund/general purpose revenues, the proportion funded with state  
21 restricted revenues, the proportion funded with federal revenues, and  
22 the proportion funded with other revenues.

23 (f) A total of all out-of-state travel funded for the  
24 immediately preceding fiscal year.

25 Sec. 215. The department shall not approve the travel of more  
26 than 1 departmental employee to a specific professional development  
27 conference or training seminar that is located outside of this state

1 unless the professional development conference or training seminar is  
2 funded by a federal or private funding source and requires more than  
3 1 person from a department to attend, or the conference or training  
4 seminar includes multiple issues in which 1 employee from the  
5 department does not have expertise.

6       Sec. 216. The department shall not take disciplinary action  
7 against an employee who communicates truthfully and factually with a  
8 member of the legislature or his or her staff.

9       Sec. 217. The state superintendent of public instruction shall  
10 take all reasonable steps to ensure businesses in deprived and  
11 depressed communities compete for and perform contracts to provide  
12 services or supplies, or both. The director shall strongly encourage  
13 firms with which the department contracts to subcontract with  
14 certified businesses in depressed and deprived communities for  
15 services, supplies, or both.

16       Sec. 218. The department and agencies receiving appropriations  
17 in part 1 shall receive and retain copies of all reports funded from  
18 appropriations in part 1. Federal and state guidelines for short-term  
19 and long-term retention of records shall be followed. The department  
20 may electronically retain copies of reports unless otherwise required  
21 by federal and state guidelines.

22       Sec. 219. (1) In addition to the funds appropriated in part 1,  
23 there is appropriated an amount not to exceed \$5,000,000.00 for  
24 federal contingency funds. These funds are not available for  
25 expenditure until they have been transferred to another line item in  
26 this act under section 393(2) of the management and budget act, 1984  
27 PA 431, MCL 18.1393.



1           (2) In addition to the funds appropriated in part 1, there is  
2 appropriated an amount not to exceed \$700,000.00 for state restricted  
3 contingency funds. These funds are not available for expenditure  
4 until they have been transferred to another line item in this act  
5 under section 393(2) of the management and budget act, 1984 PA 431,  
6 MCL 18.1393.

7           (3) In addition to the funds appropriated in part 1, there is  
8 appropriated an amount not to exceed \$250,000.00 for local  
9 contingency funds. These funds are not available for expenditure  
10 until they have been transferred to another line item in this act  
11 under section 393(2) of the management and budget act, 1984 PA 431,  
12 MCL 18.1393.

13           (4) In addition to the funds appropriated in part 1, there is  
14 appropriated an amount not to exceed \$3,000,000.00 for private  
15 contingency funds. These funds are not available for expenditure  
16 until they have been transferred to another line item in this act  
17 under section 393(2) of the management and budget act, 1984 PA 431,  
18 MCL 18.1393.

19           Sec. 220. The department shall provide data requested by a  
20 member of the legislature, his or her staff, or the house and senate  
21 fiscal agencies in a timely manner.

22           Sec. 221. Funds appropriated in part 1 shall not be used by a  
23 principal executive department, state agency, or authority to hire a  
24 person to provide legal services that are the responsibility of the  
25 attorney general. This prohibition does not apply to legal services  
26 for bonding activities and for those activities that the attorney  
27 general authorizes.

1           Sec. 225. It is the intent of the legislature that not later  
2 than 60 days after the state receives audited membership counts from  
3 intermediate school districts, the state superintendent of public  
4 instruction shall investigate and report to the legislature on the  
5 scope of and proposed solutions to pupil membership fraud and the  
6 incidence of students counted in membership in a district and not  
7 remaining in that district for the balance of the school year.

8           Sec. 226. Not later than November 15, 2013, the department  
9 shall prepare and transmit a report that provides for estimates of  
10 the total general fund/general purpose appropriation lapses at the  
11 close of the fiscal year. This report shall summarize the projected  
12 year-end general fund/general purpose appropriation lapses by major  
13 departmental program or program areas. The report shall be  
14 transmitted to the office of the state budget, the chairpersons of  
15 the senate and house appropriations committees, and the senate and  
16 house fiscal agencies.

17           Sec. 227. Within 14 days after the release of the executive  
18 budget recommendation, the department shall provide the state budget  
19 director, the senate and house appropriations chairs, the senate and  
20 house appropriations subcommittees responsible for the department  
21 budget, respectively, and the senate and house fiscal agencies with  
22 an annual report on estimated state restricted fund balances, state  
23 restricted fund projected revenues, and state restricted fund  
24 expenditures for the fiscal years ending September 30, 2012 and  
25 September 30, 2013.

26           Sec. 229. The department and the superintendent of public  
27 instruction shall use funds appropriated in part 1 to ensure that all

1 of the activities and duties required to be carried out by the  
2 department and the superintendent of public instruction under section  
3 1280c of the revised school code, 1976 PA 451, MCL 380.1280c, are  
4 completed not later than the deadlines prescribed in that section.

5 **STATE BOARD/OFFICE OF THE SUPERINTENDENT**

6 Sec. 301. (1) The appropriations in part 1 may be used for per  
7 diem payments to the state board for meetings at which a quorum is  
8 present or for performing official business authorized by the state  
9 board. The per diem payments shall be at a rate as follows:

10 (a) State board of education - president - \$110.00 per day.

11 (b) State board of education - member other than president -  
12 \$100.00 per day.

13 (2) A state board of education member shall not be paid a per  
14 diem for more than 30 days per year.

15 Sec. 302. From the amount appropriated in part 1 to the state  
16 board of education, not more than \$35,000.00 shall be expended for  
17 in-state travel and out-of-state travel directly related to the  
18 duties of the state board of education.

19 **MICHIGAN SCHOOLS FOR THE DEAF AND BLIND**

20 Sec. 402. For each student enrolled at the Michigan schools for  
21 the deaf and blind, the department shall assess the intermediate  
22 school district of residence 100% of the cost of operating the  
23 student's instructional program. The amount shall exclude room and  
24 board related costs and the cost of weekend transportation between  
25 the school and the student's home.

1           Sec. 405. The department may assist the department of community  
2 health, other departments, and local school districts to secure  
3 reimbursement for eligible services provided in Michigan schools from  
4 the federal Medicaid program. The department may submit reports of  
5 direct expenses related to this effort to the department of community  
6 health for reimbursement.

7           Sec. 406. (1) The Michigan schools for the deaf and blind may  
8 promote its residential program as a possible appropriate option for  
9 children who are deaf or hard of hearing or who are blind or visually  
10 impaired. The Michigan schools for the deaf and blind shall  
11 distribute information detailing its services to all intermediate  
12 school districts in the state.

13           (2) Upon knowledge of or recognition by an intermediate school  
14 district that a child in the district is deaf or hard of hearing or  
15 blind or visually impaired, the intermediate school district shall  
16 provide to the parents of the child the literature distributed by the  
17 Michigan schools for the deaf and blind to intermediate school  
18 districts under subsection (1).

19           (3) Parents will continue to have a choice regarding the  
20 educational placement of their deaf or hard-of-hearing children.

21           Sec. 407. Revenue received by the Michigan schools for the deaf  
22 and blind from gifts, bequests, and donations that is unexpended at  
23 the end of the state fiscal year may be carried over to the  
24 succeeding fiscal year and shall not revert to the general fund.

25           **PROFESSIONAL PREPARATION SERVICES**

26           Sec. 501. From the funds appropriated in part 1 for

1 professional preparation services, the department shall maintain the  
2 professional personnel register and certificate revocation/felony  
3 conviction files.

4       Sec. 502. The department shall authorize teacher preparation  
5 institutions to provide an alternative program by which up to 1/2 of  
6 the required student internship or student teaching credits may be  
7 earned through substitute teaching. The department shall require that  
8 teacher preparation institutions collaborate with school districts to  
9 ensure that the quality of instruction provided to student teachers  
10 is comparable to that required in a traditional student teaching  
11 program.

12       Sec. 506. Revenue received from teacher testing fees that is  
13 unexpended at the end of the state fiscal year may be carried over to  
14 the succeeding fiscal year and shall not revert to the general fund.

15       OFFICE OF EDUCATIONAL IMPROVEMENT AND INNOVATION

16       Sec. 601. From the amount appropriated in part 1 for the office  
17 of educational improvement and innovation, there is allocated  
18 \$600,000.00 and 5.5 FTE positions to operate a charter school office  
19 to administer charter school legislation and associated regulations,  
20 and to coordinate the activities of the department relating to  
21 charter schools.

22       INFORMATION TECHNOLOGY

23       Sec. 701. The department shall work in collaboration with the  
24 center for educational performance and information to support the  
25 comprehensive educational information system and all data collection

1 and reporting efforts of the department.

2 **LIBRARY OF MICHIGAN**

3       Sec. 801. In addition to the funds appropriated in part 1, the  
4 funds collected by the department for document reproduction and  
5 services; conferences, workshops, and training classes; and the use  
6 of specialized equipment, facilities, and software are appropriated  
7 for all expenses necessary to provide the required services. These  
8 funds are available for expenditure when they are received and may be  
9 carried forward into the next succeeding fiscal year.

10       Sec. 803. It is the intent of the legislature that the library  
11 of Michigan and the component programs currently within the library  
12 of Michigan shall be kept together in a state department.

13       Sec. 804. From the funds appropriated in part 1 and other  
14 funding available, the department and library of Michigan shall  
15 maintain custody of the non-Michigan genealogy and all Michigan-  
16 specific collections. These collections shall continue to be made  
17 available to the public.

18 **GRANTS ADMINISTRATION AND SCHOOL SUPPORT SERVICES**

19       Sec. 901. Within 10 days of the receipt of a grant appropriated  
20 in the federal and private grants line item in part 1, the department  
21 shall notify the house and senate chairpersons of the appropriations  
22 subcommittees responsible for the department budget, the house and  
23 senate fiscal agencies, and the state budget director of the receipt  
24 of the grant, including the funding source, purpose, and amount of  
25 the grant.

1           Sec. 903. By not later than March 1, 2013, the department shall  
2 work with districts that operate as a school of excellence cyber  
3 school as defined in section 551 of the revised school code, 1976 PA  
4 451, MCL 380.551, and districts that operate an alternative education  
5 program with a seat-time waiver under section 101 of the state school  
6 aid act of 1979, 1979 PA 94, MCL 388.1701, to provide a report to the  
7 house and senate chairpersons of the appropriations subcommittees  
8 responsible for the department budget, the house and senate fiscal  
9 agencies, and the state budget director on all of the following:

10           (a) Each district operating a program and the districts that  
11 enroll students in their program.

12           (b) The total number of students and membership pupils enrolled  
13 in each program.

14           (c) The district in which each pupil is enrolled if other than  
15 the district with the seat-time wavier or the cyber school.

16           (d) The district in which the pupil was enrolled prior to  
17 enrolling in the cyber school or the district with a seat-time waiver  
18 program.

19           (e) The number of participating students who had previously  
20 dropped out of school.

21           (f) The number of participating students who had previously  
22 been expelled from school.

23           (g) The cost per pupil paid to each online education provider.

24           (h) The cost per pupil charged to school districts that enroll  
25 their students in the program.

26           (i) The name of each online education provider contracted by a  
27 district with a seat-time waiver or a cyber school and the state in

1 which the online education provider is located.

2 **OFFICE OF GREAT START**

3 Sec. 1001. The amount appropriated in part 1 for early  
4 childhood grants shall be distributed, to the extent allowable under  
5 federal law, for the purpose of local or direct programming for early  
6 childhood participants. Funding appropriated in part 1 for early  
7 childhood grants shall not be used for the support of administration  
8 for the early childhood investment corporation.

9 Sec. 1002. (1) From the amount appropriated in part 1, the  
10 department shall contract for a report that updates the information  
11 and data in the previously completed analysis published by the W.K.  
12 Kellogg Foundation entitled "Building a Sustainable Future - Analysis  
13 of the Fiscal Resources Supporting Children from Birth Through Age 8  
14 in Michigan".

15 (2) The report identified in subsection (1) shall include at  
16 least the following:

17 (a) Each source and amount of early childhood funding.

18 (b) The agency responsible for distributing the funding  
19 identified in subdivision (a).

20 (c) The recipients of each type of funding identified in  
21 subdivision (a).

22 (d) For each recipient identified in subdivision (c), the  
23 dollar amount and percentage of funding spent for administrative  
24 purposes.

25 (e) A fiscal map of federal, state, and private expenditures on  
26 programs and services for children, from birth through age 8 and



1 their families.

2 (f) An analysis of the effectiveness of early childhood  
3 programs in ensuring that funding is used to provide services for  
4 children and families and the efficiency of any funding spent on  
5 administration, highlighting the diversification and adequacy of  
6 existing funding, the stability and flexibility of available programs  
7 and funding sources, and the coordination of funding from multiple  
8 public and private sources.

9 (3) The updated information and data shall be included in a  
10 report to the legislature along with any related recommendations the  
11 department may have to ensure that children are developmentally ready  
12 to succeed in school at the time of school entry.

13 (4) The report shall be completed not later than May 15, 2013,  
14 and, upon completion, the report shall be transmitted to the state  
15 budget director, the chairpersons of the senate and house of  
16 representatives committees on appropriations and the appropriations  
17 subcommittees responsible for the department of education budget, and  
18 the senate and house fiscal agencies.

Sec. 1201. It is the intent of the legislature to provide

1 appropriations are anticipated to be the same as those for fiscal  
2 year 2012-2013, except that the line items will be adjusted for  
3 changes in caseload and related costs, federal fund match rates,  
4 economic factors, and available revenue. These adjustments will be  
5 determined after the January 2013 consensus revenue estimating  
6 conference.
