- Sec. 1. This act shall be known and may be cited as the "Michigan Alzheimer's association fund act".

- (a) "Department" means the department of treasury.
- (b) "Fund" means the Michigan Alzheimer's association fund created in section 5.
- Sec. 5. (1) The Michigan Alzheimer's association fund is created in the department to provide funds to benefit the programs and services for unpaid caregivers of individuals with Alzheimer's

- 1 disease provided by the greater Michigan chapter and the Michigan

- 3 shall be the administrator of the fund for auditing purposes.
- 4 (2) The state treasurer shall credit to the fund all amounts

- 7 source for deposit into the fund.
- 8 (3) The state treasurer shall direct the investment of the
