

HOUSE BILL No. 5372

February 8, 2012, Introduced by Rep. Genetski and referred to the Committee on Appropriations.

A bill to amend 1979 PA 94, entitled "The state school aid act of 1979," by amending sections 11, 17b, 201, and 236 (MCL 388.1611, 388.1617b, 388.1801, and 388.1836), section 11 as amended by 2011 PA 299, section 17b as amended by 2007 PA 137, and sections 201 and 236 as added by 2011 PA 62.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 11. (1) ~~Subject to subsection (3), for the fiscal year~~

4 ~~solely for the purpose of funding the primary funding formula~~
5 ~~calculated under section 20, in accordance with federal law.~~
6 Subject to subsection (3), for the fiscal year ending September 30,
7 ~~2012, 2013~~, there is appropriated for the public schools of this
8 state and certain other state purposes relating to education the
9 sum of ~~\$10,887,098,700.00~~ \$_____ from the state school
10 aid fund and the sum of ~~\$118,642,400.00~~ \$_____ from the
11 general fund. In addition, all other available federal funds,
12 except those otherwise appropriated under section 11p, are
13 appropriated for the fiscal year ~~ending September 30, 2011 and for~~
14 ~~the fiscal year ending September 30, 2012-2013~~.

15 (2) The appropriations under this section shall be allocated
16 as provided in this article. Money appropriated under this section
17 from the general fund shall be expended to fund the purposes of
18 this article before the expenditure of money appropriated under
19 this section from the state school aid fund.

20 (3) Any general fund allocations under this article that are
21 not expended by the end of the state fiscal year are transferred to
22 the school aid stabilization fund created under section 11a.

23 Sec. 17b. (1) Not later than October 20, November 20, December
24 20, January 20, February 20, March 20, April 20, May 20, June 20,
25 July 20, and August 20, the department shall prepare electronic
26 files of the amount to be distributed under this act in the
27 installment to the districts and intermediate districts and deliver

1 the electronic files to the state treasurer, and the state
2 treasurer shall pay the installments on each of those dates or, if
3 the date is not a business day, on the next business day following
4 that date. Except as otherwise provided in this act, the portion of
5 the district's or intermediate district's state fiscal year
6 entitlement to be included in each installment shall be 1/11. A
7 district or intermediate district shall accrue the payments
8 received in July and August to the school fiscal year ending the
9 immediately preceding June 30.

10 (2) The state treasurer shall make payment under this section
11 by drawing a warrant in favor of the treasurer of each district or
12 intermediate district for the amount payable to the district or
13 intermediate district according to the electronic files and
14 delivering the warrant to the treasurer of each district or
15 intermediate district, or if the state treasurer receives a written
16 request by the treasurer of the district or intermediate district
17 specifying an account, by electronic funds transfer to that account
18 of the amount payable to the district or intermediate district
19 according to the electronic files. The department may make
20 adjustments in payments made under this section through additional
21 payments when changes in law or errors in computation cause the
22 regularly scheduled payment to be less than the amount to which the
23 district or intermediate district is entitled pursuant to this act.

24 (3) Except as otherwise provided in this act, grant payments
25 to districts and intermediate districts under this act shall be
26 paid according to the installment **PAYMENT** schedule under subsection
27 (1).

1 (4) Upon the written request of a district or intermediate
 2 district and the submission of proof satisfactory to the department
 3 of a need of a temporary and nonrecurring nature, the
 4 superintendent, with the written concurrence of the state treasurer
 5 and the state budget director, may authorize an advance release of
 6 funds due a district or intermediate district under this act. An
 7 advance authorized under this subsection shall not cause funds to
 8 be paid to a district or intermediate district more than 30 days
 9 earlier than the established payment date for those funds.
