

HOUSE BILL No. 5849

September 11, 2012, Introduced by Reps. Bauer, Lane, Barnett, Segal, Hovey-Wright, Bledsoe, Byrum, Slavens, Lipton, Johnson, Liss, Rogers, Denby, Hughes, Kowall, Shaughnessy, LaFontaine, Price, Haines, Jenkins, Stapleton, Brown and Oakes and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
(MCL 257.1 to 257.923) by adding section 811v.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 **SEC. 811V. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER**
2 **SECTION 811E AND ISSUE UNDER SECTION 811F A FUND-RAISING PLATE**
3 **RECOGNIZING THE GIRL SCOUTS OF AMERICA. THE SECRETARY OF STATE IN**
4 **CONJUNCTION WITH THE GIRL SCOUTS OF AMERICA SHALL DESIGN THE FUND-**
5 **RAISING PLATES AUTHORIZED IN THIS SECTION.**

6 **(2) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY**
7 **FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING THE GIRL SCOUTS OF**
8 **AMERICA TO THE STATE TREASURER, WHO SHALL CREDIT THE DONATION MONEY**
9 **TO THE GIRL SCOUTS OF MICHIGAN FUND ESTABLISHED UNDER THE GIRL**
10 **SCOUTS OF MICHIGAN FUND ACT, 2010 PA 347, MCL 206.921 TO 206.926.**

11 **(3) DONATION MONEY CREDITED TO THE GIRL SCOUTS OF MICHIGAN**

1 FUND UNDER SUBSECTION (2) SHALL BE DISTRIBUTED AS FOLLOWS:

2 (A) MONEY RAISED FROM THE SALE OF A FUND-RAISING PLATE
3 RECOGNIZING THE GIRL SCOUTS OF AMERICA IN A COUNTY SHALL BE
4 DISTRIBUTED TO THE GIRL SCOUT COUNCIL OF THAT COUNTY.

5 (B) IF A COUNTY IS SERVED BY MORE THAN 1 LOCAL GIRL SCOUT
6 COUNCIL, MONEY RAISED FROM THE SALE OF A FUND-RAISING PLATE
7 RECOGNIZING THE GIRL SCOUTS OF AMERICA SHALL BE DISTRIBUTED TO EACH
8 GIRL SCOUT COUNCIL WITHIN THE COUNTY BASED ON THE PERCENTAGE OF
9 GIRL SCOUT MEMBERSHIP IN THAT COUNTY.

10 Enacting section 1. This amendatory act does not take effect
11 unless Senate Bill No. ____ or House Bill No. ____ (request no.
12 06287'12) of the 96th Legislature is enacted into law.
