A bill to amend 1961 PA 236, entitled  
"Revised judicature act of 1961,"  
by amending sections 518, 524, 8116, 8121, 8121a, and 8123 (MCL  
600.518, 600.524, 600.8116, 600.8121, 600.8121a, and 600.8123),  
section 518 as amended by 2006 PA 99, section 524 as amended by  
2012 PA 35, section 8116 as amended by 2012 PA 19, section 8121 as  
amended by 2012 PA 37, section 8121a as amended by 1988 PA 135, and  
section 8123 as amended by 2012 PA 624.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 518. The seventeenth judicial circuit consists of the  
2 county of Kent and has ~~9~~**10** judges. Subject to section 550, this  
3 judicial circuit may have 1 additional judge ~~effective~~**BEGINNING**  
4 January 1, ~~2007~~**2017**.

5           Sec. 524. (1) Except as provided in subsection (2), the

1 twenty-third judicial circuit consists of the counties of Alcona,  
 2 Arenac, Iosco, and Oscoda and has 2 judges. For purposes of the  
 3 November 2008 general election only, the term of the candidate for  
 4 circuit judge in this circuit who receives the highest number of  
 5 votes is 8 years, and the term of the candidate receiving the  
 6 second highest number of votes is 6 years.

22 **GREATEST NUMBER OF VOTES IS 6 YEARS.**

23           **(B) THE CLERKS OF THE CITIES OF WESTLAND AND WAYNE SHALL FILE**  
24 **COPIES OF THE RESOLUTIONS WITH THE STATE COURT ADMINISTRATOR, WHO,**  
25 **AS AUTHORIZED BY THE SUPREME COURT, SHALL NOTIFY THE ELECTIONS**  
26 **DIVISION OF THE DEPARTMENT OF STATE THAT THE CONSOLIDATION HAS BEEN**  
27 **APPROVED UNDER THIS SECTION. A RESOLUTION THAT IS FILED BEFORE**

1 JANUARY 2, 2015 IS A VALID APPROVAL OF THE CONSOLIDATION.

2 (C) BY PROPOSING OR AUTHORIZING THE CONSOLIDATION OF THE  
3 EIGHTEENTH AND TWENTY-NINTH DISTRICTS, THE LEGISLATURE IS NOT  
4 CREATING A NEW OBLIGATION FOR ANY AFFECTED DISTRICT CONTROL UNIT.  
5 IF A DISTRICT CONTROL UNIT, ACTING THROUGH ITS GOVERNING BODY,  
6 APPROVES THE CONSOLIDATION, THEN THE APPROVAL CONSTITUTES AN  
7 EXERCISE OF THE DISTRICT CONTROL UNIT'S OPTION TO INCREASE THE  
8 LEVEL OF ACTIVITY AND SERVICE OFFERED IN THAT DISTRICT CONTROL UNIT  
9 BEYOND THAT REQUIRED BY EXISTING LAW, AS THE ELEMENTS OF THAT
