

SUBSTITUTE FOR
SENATE BILL NO. 903

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
(MCL 257.1 to 257.923) by adding section 811z.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 811Z. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
2 SECTION 811E AND ISSUE UNDER SECTION 811F A FUND-RAISING PLATE
3 RECOGNIZING BE THE MATCH. THE SECRETARY OF STATE SHALL DESIGN THE
4 FUND-RAISING PLATES AUTHORIZED IN THIS SECTION.

5 (2) THE BE THE MATCH FUND IS CREATED WITHIN THE STATE
6 TREASURY. THE STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS
7 FROM ANY SOURCE FOR DEPOSIT INTO THE FUND. THE STATE TREASURER
8 SHALL DIRECT THE INVESTMENT OF THE FUND. THE STATE TREASURER SHALL
9 CREDIT TO THE FUND INTEREST AND EARNINGS FROM FUND INVESTMENTS.

1 MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR SHALL REMAIN IN
2 THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.

3 (3) THE SECRETARY OF STATE SHALL TRANSFER THE DONATION MONEY
4 FROM THE SALE OF FUND-RAISING PLATES RECOGNIZING BE THE MATCH TO
5 THE STATE TREASURER, WHO SHALL CREDIT THE DONATION MONEY TO THE BE
6 THE MATCH FUND CREATED UNDER SUBSECTION (2).

7 (4) THE STATE TREASURER SHALL DISBURSE MONEY IN THE BE THE
8 MATCH FUND CREATED UNDER SUBSECTION (2) ON A QUARTERLY BASIS TO BE
9 THE MATCH.

10 (5) THE SECRETARY OF STATE SHALL BE THE ADMINISTRATOR OF THE
11 BE THE MATCH FUND CREATED UNDER SUBSECTION (2) FOR AUDITING
12 PURPOSES.

13 (6) MONEY FROM THE BE THE MATCH FUND SHALL BE EXPENDED ON
14 RESEARCH, TECHNOLOGY, PATIENT SUPPORT, AND EDUCATION REGARDING BONE
15 MARROW DONATION AND TRANSPLANTATION AND THE TESTING OF NEW BE THE
16 MATCH REGISTRANTS.
