SUBSTITUTE FOR HOUSE BILL NO. 4481

A bill to amend 1984 PA 270, entitled "Michigan strategic fund act," by amending sections 88k and 88n (MCL 125.2088k and 125.2088n), section 88k as amended by 2012 PA 145 and section 88n as added by 2005 PA 215.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 88k. (1) The strategic economic investment and
- 2 commercialization board is created within the fund. The THROUGH
- 3 OCTOBER 17, 2010, THE commercialization board shall exercise its
- 4 powers, duties, and decision-making authority under this chapter
- 5 SECTION independently of the fund, the fund board, and the
- 6 department of treasury. **BEGINNING OCTOBER 18, 2010, THE FUND BOARD**
- 7 SHALL EXERCISE ALL POWERS, DUTIES, AND DECISION-MAKING AUTHORITY OF
- 8 THE STRATEGIC ECONOMIC INVESTMENT AND COMMERCIALIZATION BOARD.

- 1 (2) The commercialization—FUND board shall award grants and
- 2 loans UNDER THIS SECTION from the 21st century jobs trust fund
- 3 created in the Michigan trust fund act, 2000 PA 489, MCL 12.251 to
- 4 12.256, 12.260, and the investment fund only for basic research,
- 5 applied research, university technology transfer, and
- 6 commercialization of products, processes, and services to encourage
- 7 the development of competitive edge technologies to create jobs in
- 8 this state.
- 9 (3) Subject to subsection (2), the fund as determined by the
- 10 commercialization board shall establish a competitive process to
- 11 award grants and make loans UNDER THIS SECTION for competitive edge
- 12 technologies. The competitive process shall include, but is not
- 13 limited to, the following:
- 14 (a) A provision that the applications must be reviewed by a
- 15 joint-evaluation committee. Scientific and technical merit,
- 16 personnel expertise, commercial merit, and the ability to leverage
- 17 additional funding may be given equal weight in the review and
- 18 scoring process as determined by the fund board.
- 19 (b) A preference for proposals that can contribute to the
- 20 development of economic diversification or the creation of
- 21 employment opportunities in this state.
- 22 (c) A provision that out-of-state business must have a
- 23 significant existing or proposed business presence in this state.
- 24 (d) A provision that the program will utilize contracts with
- 25 measurable milestones, clear objectives, provisions to revoke
- 26 awards for breach of contract OR FAILING TO MEET MEASURABLE
- 27 MILESTONES, REPAYMENT OF GRANTS FOR BREACH OF CONTRACT OR FOR

- 1 FAILING TO MEET MEASURABLE OUTCOMES, and repayment provisions for
- 2 loans given to qualified businesses that leave Michigan within 3
- 3 years of the execution of the contract, or THAT otherwise breach
- 4 the terms of the contract, OR THAT FAIL TO MEET MEASURABLE
- 5 OUTCOMES.
- 6 (e) A provision that the applicant leverage other resources as
- 7 a condition of the grant or loan. If an applicant is seeking a
- 8 grant or a loan under this chapter SECTION to match federal funds
- 9 for small business innovation research or small business technology
- 10 transfer programs, the grant or loan under this chapter SECTION
- 11 shall not exceed 25% of the federal funds and must leverage third-
- 12 party commercialization funding at both the phase I and phase II
- 13 levels.
- 14 (f) Limit overhead rates, administrative fees, and management
- 15 fees for recipients of awards to not more than 25% of the award.
- 16 (g) Except as provided in subdivision (e), a provision that
- 17 grants can only be awarded to Michigan institutions of higher
- 18 education, Michigan nonprofit research institutions, and Michigan
- 19 nonprofit corporations.
- 20 (h) A preference for collaborations between institutions of
- 21 higher education, Michigan nonprofit research institutions,
- 22 Michigan nonprofit corporations, and qualified businesses.
- (i) A provision authorizing the award of grants to
- 24 institutions of higher education to serve as match to promote or
- 25 secure the award and receipt of competitively awarded federal
- 26 research grants related to competitive edge technologies. A
- 27 matching grant shall not exceed 10% of the amount of the

- 1 competitively awarded federal research grants received.
- 2 (j) A provision encouraging the redevelopment of existing
- 3 scientific wet lab space for the commercialization of life science
- 4 technology.
- 5 (k) A preference for proposals that meet 1 or more of the
- 6 following:
- 7 (i) Forecast revenues within 2 years.
- 8 (ii) Have outside investments from investors with experience
- 9 and management teams with experience in the industry targeted by
- 10 the proposal.
- 11 (iii) Have outside directors with expertise in the industry
- 12 targeted by the proposal.
- 13 (4) The commercialization FUND board shall establish standards
- 14 to ensure that money expended under this chapter SECTION will
- 15 result in economic benefit to this state and ensure that a major
- 16 share of the business activity resulting from the expenditures
- 17 occurs in this state.
- 18 (5) The commercialization board shall ensure that a recipient
- 19 of money expended under this chapter agrees as a condition of
- 20 receiving the money not to use the money for any of the following:
- 21 (a) The development of a stadium or arena for use by a
- 22 professional sports team.
- 23 (b) The development of a casino regulated by this state under
- 24 the Michigan gaming control and revenue act, 1996 IL 1, MCL 432.201
- 25 to 432.226, a casino at which gaming is conducted under the Indian
- 26 gaming regulatory act, Public Law 100-497, 102 Stat. 2467, or
- 27 property associated or affiliated with the operation of either type

- 1 of casino described in this subdivision, including, but not limited
- 2 to, a parking lot, hotel, motel, or retail store.
- 3 (6) The commercialization board shall establish requirements
- 4 to ensure that money expended under this section shall not be used
- 5 for any of the following:
- 6 (a) Grants or loans to a person who has been convicted of a
- 7 criminal offense incident to the application for or performance of
- 8 a state contract or subcontract. As used in this subdivision, if a
- 9 person is a business entity, then person includes affiliates,
- 10 subsidiaries, officers, directors, managerial employees as
- 11 determined by the fund board, and any person who, directly or
- 12 indirectly, holds a pecuniary interest in that business entity of
- 13 20% or more.
- 14 (b) Grants or loans to a person who has been convicted of a
- 15 criminal offense, or held liable in a civil proceeding, that
- 16 negatively reflects on the person's business integrity, based on a
- 17 finding of embezzlement, theft, forgery, bribery, falsification or
- 18 destruction of records, receiving stolen property, or violation of
- 19 state or federal antitrust statutes. As used in this subdivision,
- 20 if a person is a business entity, then person includes affiliates,
- 21 subsidiaries, officers, directors, managerial employees as
- 22 determined by the fund board, and any person who, directly or
- 23 indirectly, holds a pecuniary interest in that business entity of
- 24 20% or more.
- 25 (c) Grants or loans to induce a qualified business or a small
- 26 business to leave this state.
- 27 (d) Grants or loans that would contribute to the violation of

- 1 internationally recognized workers rights, as defined in section
- 2 507(4) of the trade act of 1974, 19 USC 2467(4), of workers in a
- 3 country other than the United States, including any designated zone
- 4 or area in that country.
- 5 (e) Grants or loans to a corporation or an affiliate of the
- 6 corporation incorporated in a tax haven country after September 11,
- 7 2001, but with the United States as the principal market for the
- 8 public trading of the corporation's stock. As used in this section,
- 9 "tax haven country" includes a country with tax laws that
- 10 facilitate avoidance by a corporation or an affiliate of the
- 11 corporation of United States tax obligations, including Barbados,
- 12 Bermuda, British Virgin Islands, Cayman Islands, Commonwealth of
- 13 the Bahamas, Cyprus, Gibraltar, Isle of Man, the Principality of
- 14 Liechtenstein, the Principality of Monaco, and the Republic of the
- 15 Seychelles.
- 16 (5) (7) When the commercialization FUND board approves a grant
- 17 or a loan under this chapter, SECTION, the commercialization FUND
- 18 board shall state the specific objective reasons the applicant was
- 19 selected over other applicants for a grant or loan under this
- 20 chapter.SECTION.
- 21 (8) After March 31, 2006, before adopting a resolution that
- 22 establishes or substantially changes a program operated by the
- 23 commercialization board, including any fees, charges, or penalties
- 24 attached to that program, the commercialization board shall give
- 25 notice of the proposed resolution to the governor, to the secretary
- 26 of the senate, to the clerk of the house of representatives, to
- 27 members of the senate and house of representatives standing

committees on appropriations, and to each person who requested from

- 4 any conflict of interest, criminal convictions, investigations by

- 6 or court, and any pertinent litigation regarding the conduct of the
- 7 entity.
- 8 (1) (3) All contracts approved by the fund for 21st century
- 9 investments and all contracts approved by the commercialization
- 10 board OR FUND BOARD for grants or loans under this chapter shall
- 11 contain a provision that the auditor general has access to the
- 12 books and records, including financial records and all other
- 13 information and data relevant to the terms of the contract related
- 14 to the use of the grant, loan, or 21st century investment.
- 15 (2) (4)—If the fund board or the commercialization board has a
- 16 reasonable belief that a breach of contract has occurred, the fund
- 17 has the right to have the recipient's annual financial statements
- 18 separately audited by an independent certified public accountant at
- 19 its sole cost and expense. If the audit reveals that a breach of
- 20 contract has occurred, the recipient shall reimburse the fund for
- 21 the fees and expenses incurred to perform the audit.

- 17 (6) Not later than March 31, 2007 and each subsequent March
- 18 31, the fund shall report to the governor, the clerk of the house
- 19 of representatives, the secretary of the senate, and the
- 20 chairpersons of the senate and house of representatives standing
- 21 committees on appropriations. The report shall contain all of the
- 22 following for the immediately preceding fiscal year that are
- 23 related to a 21st century investment made by the fund board:

- 11 (f) A statement of the amount of money in each loan reserve
- 12 fund established under the small business capital access program
- 13 required under this chapter.
- 14 (g) Any recommendations for needed changes and any other
- 15 information the board believes would be of interest to the
- 16 governor, the legislature, and the public.
- 17 (3) (7)—As a condition of receiving funding under this
- 18 chapter, the fund shall require a recipient to agree to provide to
- 19 the fund the information necessary for the fund to produce the
- 20 reports required under this section.
- 21 Enacting section 1. This amendatory act does not take effect
- 22 unless House Bill No. 4480 of the 97th Legislature is enacted into
- 23 law.
