

SUBSTITUTE FOR  
SENATE BILL NO. 51

A bill to amend 1893 PA 206, entitled  
"The general property tax act,"  
by amending section 7jj (MCL 211.7jj[1]), as added by 2006 PA 378.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 7jj. (1) Except as otherwise limited in this subsection,  
2 qualified forest property is exempt from the tax levied by a local  
3 school district for school operating purposes to the extent  
4 provided under section 1211 of the revised school code, 1976 PA  
5 451, MCL 380.1211, according to the provisions of this section.  
6 **BUILDINGS, STRUCTURES, OR LAND IMPROVEMENTS LOCATED ON QUALIFIED**  
7 **FOREST PROPERTY ARE NOT ELIGIBLE FOR THE EXEMPTION UNDER THIS**  
8 **SECTION.** The amount of qualified forest property in this state that  
9 is eligible for the exemption under this section is limited as

1 follows:

2 (a) In the fiscal year ending September 30, 2008, 300,000  
3 acres.

4 (b) In the fiscal year ending September 30, 2009, 600,000  
5 acres.

6 (c) In the fiscal year ending September 30, 2010, 900,000  
7 acres.

8 (d) In the fiscal year ending September 30, 2011 and each  
9 fiscal year thereafter, ~~1,200,000~~ 2,400,000 acres. **BEGINNING IN THE**  
10 **FISCAL YEAR ENDING SEPTEMBER 30, 2013 AND EACH FISCAL YEAR**  
11 **THEREAFTER, REAL PROPERTY ELIGIBLE FOR EXEMPTION UNDER THIS SECTION**  
12 **AS QUALIFIED FOREST PROPERTY AS A RESULT OF THE WITHDRAWAL OF THAT**  
13 **PROPERTY FROM THE OPERATION OF PART 511 OF THE NATURAL RESOURCES**  
14 **AND ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, MCL 324.51101 TO**  
15 **324.51120, AS PROVIDED IN SECTION 51108(5) OF THE NATURAL RESOURCES**  
16 **AND ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, MCL 324.51108, SHALL**  
17 **NOT BE CREDITED AGAINST THE 2,400,000 ACRES OF PROPERTY THAT ARE**  
18 **ELIGIBLE FOR EXEMPTION AS QUALIFIED FOREST PROPERTY UNDER THIS**  
19 **SECTION.**

20 (2) IF A PROPERTY OWNER IS INTERESTED IN OBTAINING AN  
21 EXEMPTION FOR QUALIFIED FOREST PROPERTY UNDER THIS SECTION, THE  
22 PROPERTY OWNER MAY CONTACT THE LOCAL CONSERVATION DISTRICT OR THE  
23 DEPARTMENT, AND THE LOCAL CONSERVATION DISTRICT OR THE DEPARTMENT  
24 SHALL ADVISE THE PROPERTY OWNER ON THE EXEMPTION PROCESS. IF  
25 REQUESTED BY THE PROPERTY OWNER, THE LOCAL CONSERVATION DISTRICT OR  
26 THE DEPARTMENT SHALL PROVIDE THE PROPERTY OWNER WITH A LIST OF  
27 QUALIFIED FORESTERS TO PREPARE A FOREST MANAGEMENT PLAN. THE

1 DEPARTMENT SHALL MAINTAIN A LIST OF QUALIFIED FORESTERS THROUGHOUT  
2 THE STATE AND SHALL MAKE THE LIST AVAILABLE TO THE CONSERVATION  
3 DISTRICTS AND TO INTERESTED PROPERTY OWNERS. TO CLAIM AN EXEMPTION  
4 UNDER SUBSECTION (1), A PROPERTY OWNER SHALL OBTAIN A FOREST  
5 MANAGEMENT PLAN FROM A QUALIFIED FORESTER AND SUBMIT A DIGITAL COPY  
6 OF THAT FOREST MANAGEMENT PLAN, AN APPLICATION FOR EXEMPTION AS  
7 QUALIFIED FOREST PROPERTY, AND A FEE OF \$50.00 TO THE DEPARTMENT ON  
8 A FORM CREATED BY THE DEPARTMENT BY SEPTEMBER 1 PRIOR TO THE TAX  
9 YEAR WITHIN WHICH THE EXEMPTION IS REQUESTED. A FOREST MANAGEMENT  
10 PLAN IS NOT SUBJECT TO THE FREEDOM OF INFORMATION ACT, 1976 PA 442,  
11 MCL 15.231 TO 15.246. THE DEPARTMENT SHALL FORWARD A COPY OF THE  
12 APPLICATION TO THE LOCAL CONSERVATION DISTRICT FOR REVIEW AND TO  
13 THE LOCAL TAX COLLECTING UNIT FOR NOTIFICATION OF THE APPLICATION.

14 (3) A CONSERVATION DISTRICT SHALL REVIEW THE APPLICATION TO  
15 DETERMINE IF THE APPLIED-FOR PROPERTY MEETS THE MINIMUM  
16 REQUIREMENTS SET FORTH IN SUBSECTION (16) (I) FOR ENROLLING INTO THE  
17 QUALIFIED FOREST PROGRAM. A CONSERVATION DISTRICT SHALL RESPOND  
18 WITHIN 45 DAYS OF THE DATE OF ITS RECEIPT OF THE APPLICATION  
19 INDICATING WHETHER THE PROPERTY IN THE APPLICATION IS ELIGIBLE FOR  
20 ENROLLMENT. IF THE CONSERVATION DISTRICT DOES NOT RESPOND WITHIN 45  
21 DAYS OF ITS RECEIPT OF THE APPLICATION, THE PROPERTY SHALL BE  
22 CONSIDERED ELIGIBLE FOR THE EXEMPTION UNDER THIS SECTION.

23 (4) THE DEPARTMENT SHALL REVIEW THE APPLICATION, COMMENTS FROM  
24 THE CONSERVATION DISTRICT, AND THE FOREST MANAGEMENT PLAN TO  
25 DETERMINE IF THE PROPERTY IS ELIGIBLE FOR THE EXEMPTION UNDER THIS  
26 SECTION. THE DEPARTMENT SHALL REVIEW THE FOREST MANAGEMENT PLAN TO  
27 DETERMINE IF THE ELEMENTS REQUIRED IN SUBSECTION (16) (E) ARE IN THE

1 PLAN. WITHIN 90 DAYS OF ITS RECEIPT OF THE APPLICATION, FOREST  
2 MANAGEMENT PLAN, AND FEE, THE DEPARTMENT SHALL REVIEW THE  
3 APPLICATION AND IF THE APPLICATION AND SUPPORTING DOCUMENTS ARE NOT  
4 IN COMPLIANCE, THE DEPARTMENT SHALL NOTIFY THE PROPERTY OWNER OF  
5 DENIAL. IF THE APPLICATION AND SUPPORTING DOCUMENTS ARE IN  
6 COMPLIANCE WITH THE REQUIREMENTS OF THIS SECTION, THE DEPARTMENT  
7 SHALL APPROVE THE APPLICATION AND SHALL PREPARE A QUALIFIED FOREST  
8 SCHOOL TAX AFFIDAVIT, IN RECORDABLE FORM, INDICATING ALL OF THE  
9 FOLLOWING:

10 (A) THE NAME OF THE PROPERTY OWNER.

11 (B) THE LEGAL DESCRIPTION OF THE PROPERTY.

12 (C) THE YEAR THE APPLICATION WAS SUBMITTED FOR THE EXEMPTION.

13 (D) A STATEMENT THAT THE PROPERTY OWNER IS ATTESTING THAT THE  
14 PROPERTY FOR WHICH THE EXEMPTION IS CLAIMED IS QUALIFIED FOREST  
15 PROPERTY AND WILL BE MANAGED ACCORDING TO THE APPROVED FOREST  
16 MANAGEMENT PLAN.

17 (5) THE DEPARTMENT SHALL SEND A QUALIFIED FOREST SCHOOL TAX  
18 AFFIDAVIT PREPARED UNDER SUBSECTION (4) TO THE PROPERTY OWNER FOR  
19 EXECUTION. THE 90-DAY REVIEW PERIOD BY THE DEPARTMENT MAY BE  
20 EXTENDED UPON REQUEST OF THE PROPERTY OWNER. THE PROPERTY OWNER  
21 SHALL EXECUTE THE QUALIFIED FOREST SCHOOL TAX AFFIDAVIT AND SHALL  
22 HAVE THE EXECUTED QUALIFIED FOREST SCHOOL TAX AFFIDAVIT RECORDED BY  
23 THE REGISTER OF DEEDS IN THE COUNTY IN WHICH THE PROPERTY IS  
24 LOCATED. THE PROPERTY OWNER SHALL PROVIDE A COPY OF THE QUALIFIED  
25 FOREST SCHOOL TAX AFFIDAVIT TO THE DEPARTMENT. THE DEPARTMENT SHALL  
26 PROVIDE 1 COPY OF THE QUALIFIED FOREST SCHOOL TAX AFFIDAVIT TO THE  
27 CONSERVATION DISTRICT AND 1 COPY TO THE DEPARTMENT OF TREASURY.

1 THESE COPIES MAY BE SENT ELECTRONICALLY.

2 (6) IF THE APPLICATION IS DENIED, THE PROPERTY OWNER HAS 30  
3 DAYS FROM THE DATE OF NOTIFICATION OF THE DENIAL BY THE DEPARTMENT  
4 TO INITIATE AN APPEAL OF THAT DENIAL. AN APPEAL OF THE DENIAL SHALL  
5 BE BY CERTIFIED LETTER TO THE DIRECTOR OF THE DEPARTMENT.

6 (7) ~~(2)~~ To claim an exemption under subsection (1), the owner  
7 of qualified forest property shall ~~file an affidavit claiming the~~  
8 ~~exemption and an approved forest management plan or a certificate~~  
9 ~~provided by a third party certifying organization with the~~ **PROVIDE**  
10 **A COPY OF THE RECORDED QUALIFIED FOREST SCHOOL TAX AFFIDAVIT**  
11 **ATTESTING THAT THE LAND IS QUALIFIED FOREST PROPERTY TO THE** local  
12 tax collecting unit **AND ASSESSOR** by December 31. An owner may claim  
13 an exemption under this section for not more than ~~320 acres~~ **640**  
14 **ACRES MAXIMUM OR THE EQUIVALENT OF 16 SURVEY UNITS CONSISTING OF**  
15 **1/4 OF 1/4 OF A SECTION** of qualified forest property in each local  
16 tax collecting unit. If an exemption is granted under this section  
17 for less than ~~320~~ **640** acres in a local tax collecting unit, an  
18 owner of that property may subsequently claim an exemption for  
19 additional property in that local tax collecting unit if that  
20 additional property meets the requirements of this section.

21 ~~— (3) The affidavit shall be on a form prescribed by the~~  
22 ~~department of treasury and shall require the person submitting the~~  
23 ~~affidavit to attest that the property for which the exemption is~~  
24 ~~elaimed is qualified forest property and will be managed according~~  
25 ~~to the approved forest management plan.~~

26 (8) ~~(4) The~~ **IF A COPY OF THE RECORDED QUALIFIED FOREST SCHOOL**  
27 **TAX AFFIDAVIT IS PROVIDED TO THE ASSESSOR BY THE OWNER, THE**

1 ~~assessor shall determine if the property is qualified forest~~  
2 ~~property based on a recommendation from the department of natural~~  
3 ~~resources and confirmation that the acreage limitation set forth in~~  
4 ~~subsection (1) has not been reached and if so shall exempt the~~  
5 property from the collection of the tax as provided in subsection  
6 (1) until December 31 of the year in which the property is no  
7 longer qualified forest property.

8 (9) BEGINNING IN THE YEAR THAT QUALIFIED FOREST PROPERTY IS  
9 FIRST EXEMPT UNDER THIS SECTION AND EACH YEAR THEREAFTER, THE LOCAL  
10 TAX COLLECTING UNIT SHALL COLLECT A FEE ON EACH PARCEL OF QUALIFIED  
11 FOREST PROPERTY EXEMPT UNDER THIS SECTION LOCATED IN THAT LOCAL TAX  
12 COLLECTING UNIT. THE FEE SHALL BE DETERMINED BY MULTIPLYING 2 MILLS  
13 BY THE TAXABLE VALUE OF THAT QUALIFIED FOREST PROPERTY. THE FEE  
14 SHALL BE COLLECTED AT THE SAME TIME AND IN THE SAME MANNER AS TAXES  
15 COLLECTED UNDER THIS ACT. EACH LOCAL TAX COLLECTING UNIT SHALL  
16 DISBURSE THE FEE COLLECTED UNDER THIS SUBSECTION TO THE DEPARTMENT  
17 OF TREASURY FOR DEPOSIT IN THE PRIVATE FORESTLAND ENHANCEMENT FUND  
18 CREATED IN SECTION 51305 OF THE NATURAL RESOURCES AND ENVIRONMENTAL  
19 PROTECTION ACT, 1994 PA 451, MCL 324.51305. IF PROPERTY IS NO  
20 LONGER EXEMPT AS QUALIFIED FOREST PROPERTY UNDER THIS SECTION, THE  
21 FEE UNDER THIS SUBSECTION SHALL NOT BE COLLECTED ON THAT PROPERTY.  
22 THE FEE COLLECTED IN THIS SUBSECTION SHALL BE SUBJECT TO THE  
23 PROPERTY TAX ADMINISTRATION FEE ESTABLISHED BY THE LOCAL TAX  
24 COLLECTING UNIT UNDER SECTION 44.

25 (10) ~~(5)~~ Not more than 90 days after all or a portion of the  
26 exempted property is no longer qualified forest property, the owner  
27 shall rescind the exemption for the applicable portion of the

1 property by filing with the ~~local tax collecting unit~~ REGISTER OF  
2 DEEDS FOR THE COUNTY IN WHICH THE EXEMPTED PROPERTY IS LOCATED a  
3 rescission form prescribed by the department. ~~of treasury.~~ A COPY  
4 OF THE RESCISSION FORM SHALL BE PROVIDED TO THE ASSESSOR. THE  
5 RESCISSION FORM SHALL INCLUDE A LEGAL DESCRIPTION OF THE EXEMPTED  
6 PROPERTY. An owner who fails to file a rescission as required by  
7 this subsection is subject to a penalty of \$5.00 per day for each  
8 separate failure beginning after the 90 days have elapsed, up to a  
9 maximum of \$1,000.00. This penalty shall be collected under 1941 PA  
10 122, MCL 205.1 to 205.31, and shall be deposited in the ~~general~~  
11 ~~fund of this state.~~ PRIVATE FORESTLAND ENHANCEMENT FUND.

12 (11) ~~(6)~~ An owner of property that is qualified forest  
13 property on December 31 for which an exemption was not on the tax  
14 roll may file an appeal with the July or December board of review  
15 under section 53b in the year the exemption was claimed or the  
16 immediately succeeding year. ~~An owner of property that is qualified~~  
17 ~~forest property on May 1 for which an exemption was denied by the~~  
18 ~~assessor in the year the affidavit was filed may file an appeal~~  
19 ~~with the July board of review for summer taxes or, if there is not~~  
20 ~~a summer levy of school operating taxes, with the December board of~~  
21 ~~review under section 53b.~~

22 ~~—— (7) If the assessor of the local tax collecting unit believes~~  
23 ~~that the property for which an exemption has been granted is not~~  
24 ~~qualified forest property based on a recommendation from the~~  
25 ~~department of natural resources, the assessor may deny or modify an~~  
26 ~~existing exemption by notifying the owner in writing at the time~~  
27 ~~required for providing a notice under section 24c. A taxpayer may~~

1 ~~appeal the assessor's determination to the board of review meeting~~  
2 ~~under section 30. A decision of the board of review may be appealed~~  
3 ~~to the residential and small claims division of the Michigan tax~~  
4 ~~tribunal.~~

5 (12) ~~(8)~~—If property for which an exemption has been granted  
6 under this section is not qualified forest property, the property  
7 that had been subject to that exemption shall be immediately placed  
8 on the tax roll by the local tax collecting unit if the local tax  
9 collecting unit has possession of the tax roll or by the county  
10 treasurer if the county has possession of the tax roll as though  
11 the exemption had not been granted. A corrected tax bill shall be  
12 issued for each tax year being adjusted by the local tax collecting  
13 unit if the local tax collecting unit has possession of the tax  
14 roll or by the county treasurer if the county has possession of the  
15 tax roll.

16 (13) ~~(9)~~—If **ALL OR A PORTION OF** property for which an  
17 exemption has been granted under this section is converted by a  
18 change in use and is no longer qualified forest property, ~~the~~  
19 ~~property is subject to the qualified forest property recapture tax~~  
20 ~~levied~~**AN OWNER SHALL IMMEDIATELY NOTIFY THE LOCAL TAX COLLECTING**  
21 **UNIT, THE ASSESSOR, THE DEPARTMENT, AND THE DEPARTMENT OF TREASURY**  
22 **ON A FORM CREATED BY THE DEPARTMENT. THE FORM SHALL INCLUDE A LEGAL**  
23 **DESCRIPTION OF THE EXEMPTED PROPERTY. A COPY OF THE FORM SHALL BE**  
24 **FILED WITH THE REGISTER OF DEEDS FOR THE COUNTY IN WHICH THE**  
25 **EXEMPTED PROPERTY IS LOCATED. UPON NOTICE THAT PROPERTY IS NO**

20 UNDER THIS SECTION, THE EXISTING AFFIDAVIT SHALL BE RESCINDED  
21 WITHOUT PENALTY AND THE PROPERTY SHALL BE PLACED ON THE TAX ROLL AS  
22 THOUGH THE EXEMPTION UNDER THIS SECTION HAD NOT BEEN GRANTED. IF A  
23 PROPERTY OWNER ELECTS NOT TO EXECUTE A QUALIFIED FOREST SCHOOL TAX  
24 AFFIDAVIT UNDER THIS SECTION, THE PROPERTY IS NOT SUBJECT TO THE  
25 RECAPTURE TAX PROVIDED FOR UNDER THE QUALIFIED FOREST PROPERTY

27 (14) ~~(10)~~ If qualified forest property is exempt under this

1 section, an owner of that qualified forest property shall annually  
2 report to the department ~~of natural resources~~ on a form prescribed  
3 by the department ~~of natural resources~~ the amount of timber  
4 produced on that qualified forest property and whether any  
5 buildings or structures have been constructed on the qualified  
6 forest property. **WHEN A FOREST PRACTICE OR TIMBER HARVEST HAS**  
7 **OCCURRED ON THE QUALIFIED FOREST PROPERTY DURING A CALENDAR YEAR.**  
8 **THE REPORT SHALL INDICATE THE FOREST PRACTICE COMPLETED OR THE**  
9 **VOLUME AND VALUE OF TIMBER HARVESTED ON THAT QUALIFIED FOREST**  
10 **PROPERTY. ONE COPY OF THE FORM SHALL BE FORWARDED TO THE**  
11 **CONSERVATION DISTRICT, AND 1 COPY SHALL BE RETAINED BY THE**  
12 **DEPARTMENT FOR 7 YEARS. IF IT IS DETERMINED BY THE DEPARTMENT THAT**  
13 **A FOREST PRACTICE OR HARVEST HAS OCCURRED IN A CALENDAR YEAR AND NO**  
14 **REPORT WAS FILED, A FINE OF \$500.00 MAY BE COLLECTED BY THE**  
15 **DEPARTMENT.** Beginning ~~in 2008,~~ **DECEMBER 31, 2013** and every ~~3~~ years  
16 **YEAR** thereafter, the department ~~of natural resources~~ shall provide  
17 to the standing committees of the senate and house of  
18 representatives with primary jurisdiction over forestry issues a  
19 report that includes all of the following:

20 (a) The number of acres of qualified forest property in each  
21 county.

22 (b) The amount of timber produced on qualified forest property  
23 each year.

24 **(C) THE NUMBER OF FOREST MANAGEMENT PLANS COMPLETED BY**  
25 **CONSERVATION DISTRICTS AND THE TOTAL NUMBER OF FOREST MANAGEMENT**  
26 **PLANS SUBMITTED FOR APPROVAL EACH YEAR.**

27 **(15) WHILE QUALIFIED FOREST PROPERTY IS EXEMPT UNDER THIS**

1 SECTION, THE OWNER SHALL RETAIN THE CURRENT MANAGEMENT PLAN, MOST  
2 RECENT HARVEST RECORDS, RECORDED COPY OF A RECEIPT OF THE TAX  
3 EXEMPTION, AND A MAP THAT SHOWS THE LOCATION AND SIZE OF ANY  
4 BUILDINGS AND STRUCTURES ON THE PROPERTY. THE OWNER SHALL MAKE THE  
5 DOCUMENTS AVAILABLE TO THE DEPARTMENT UPON REQUEST. THE DEPARTMENT  
6 SHALL MAINTAIN A DATABASE LISTING ALL QUALIFIED FOREST PROPERTIES,  
7 INCLUDING THE DATES INDICATED FOR FOREST PRACTICES AND HARVESTS IN  
8 THE FOREST MANAGEMENT PLAN, AND SHALL NOTIFY THE PROPERTY OWNER AND  
9 THE CONSERVATION DISTRICT IN ANY YEAR THAT FOREST PRACTICES OR  
10 HARVESTS ARE TO OCCUR. IF AN OWNER DOES NOT ACCOMPLISH FOREST  
11 PRACTICES AND HARVESTS WITHIN 3 YEARS AFTER THE TIME SPECIFIED IN  
12 THE CURRENT FOREST MANAGEMENT PLAN, AND THE PLAN HAS NOT BEEN  
13 AMENDED TO EXTEND THE DATE OF FOREST PRACTICES AND HARVESTS, THE  
14 PROPERTY IS NOT ELIGIBLE FOR THE EXEMPTION UNDER THIS SECTION AND  
15 THE PROPERTY SHALL BE PLACED ON THE TAX ROLL AS THOUGH THE  
16 EXEMPTION UNDER THIS SECTION HAD NOT BEEN GRANTED AS PROVIDED IN  
17 THIS SECTION AND SHALL BE SUBJECT TO REPAYMENT AS INDICATED IN THE  
18 QUALIFIED FOREST PROPERTY RECAPTURE TAX ACT, 2006 PA 379, MCL  
19 211.1031 TO 211.1036. INFORMATION IN THE DATABASE SPECIFIC TO AN  
20 INDIVIDUAL PROPERTY OWNER'S FOREST MANAGEMENT PLAN IS EXEMPT FROM
