

# HOUSE BILL No. 5016

September 26, 2013, Introduced by Reps. Zorn, Johnson, Pagel, Yonker, VerHeulen, MacMaster, Kurtz, Graves, Daley, Lauwers, Rendon, Jenkins, LaFontaine, O'Brien, Lori, Denby, Price, Kowall and Howrylak and referred to the Committee on Families, Children, and Seniors.

A bill to amend 1939 PA 280, entitled "The social welfare act," by amending section 57v (MCL 400.57v), as added by 2012 PA 197.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 57v. (1) The department shall work with providers of  
2 ~~automatic~~**AUTOMATED** teller machine services to create and implement  
3 a program or method of blocking access to ~~cash benefits from~~  
4 ~~Michigan bridge cards~~**FAMILY INDEPENDENCE PROGRAM ASSISTANCE** at  
5 ~~automatic~~**AUTOMATED** teller machines located in casinos, ~~or~~ casino  
6 enterprises, **LIQUOR STORES, OR ADULT ENTERTAINMENT ESTABLISHMENTS.**

7           (2) If the department requires a federal waiver to implement  
8 the provisions of this section, the department shall apply  
9 immediately upon enactment of this section for that federal waiver.

10           (3) As used in this section: ~~,"casino"~~

1 (A) "ADULT ENTERTAINMENT ESTABLISHMENT" MEANS ANY OF THE  
2 FOLLOWING:

3 (i) AN ON-PREMISES LICENSEE THAT HOLDS A TOPLESS ACTIVITY  
4 PERMIT DESCRIBED IN SECTION 916(3) OF THE MICHIGAN LIQUOR CONTROL  
5 CODE OF 1998, 1998 PA 58, MCL 436.1916.

6 (ii) ANY OTHER RETAIL ESTABLISHMENT THAT PROVIDES ADULT-  
7 ORIENTED ENTERTAINMENT IN WHICH PERFORMERS DISROBE OR PERFORM IN AN  
8 UNCLOTHED STATE FOR ENTERTAINMENT.

9 (B) SUBJECT TO SUBSECTION (4), "CASINO" and "casino  
10 enterprises"—"ENTERPRISE" mean those terms as defined in section 2  
11 of the Michigan gaming control and revenue act, 1996 IL 1, MCL  
12 432.202.

13 (C) "GAMING" MEANS THAT TERM AS DEFINED IN SECTION 2 OF THE  
14 MICHIGAN GAMING CONTROL AND REVENUE ACT, 1996 IL 1, MCL 432.202.

15 (D) "LIQUOR STORE" MEANS A RETAILER, AS THAT TERM IS DEFINED  
16 IN SECTION 111 OF THE MICHIGAN LIQUOR CONTROL CODE OF 1998, 1998 PA  
17 58, MCL 436.1111, THAT IS EXCLUSIVELY OR PRIMARILY ENGAGED IN THE  
18 SALE OF SPIRITS. THE TERM DOES NOT INCLUDE A GROCERY STORE THAT  
19 SELLS SPIRITS AND GROCERIES, INCLUDING STAPLE FOODS.

20 (E) "SPIRITS" MEANS THAT TERM AS DEFINED IN SECTION 111 OF THE  
21 MICHIGAN LIQUOR CONTROL CODE OF 1998, 1998 PA 58, MCL 436.1111.

22 (F) "STAPLE FOODS" MEANS THAT TERM AS DEFINED IN 7 USC 2012.

23 (4) AS USED IN THIS SECTION, THE TERMS CASINO AND CASINO  
24 ENTERPRISE DO NOT INCLUDE ANY OF THE FOLLOWING:

25 (A) A GROCERY STORE THAT SELLS GROCERIES, INCLUDING STAPLE  
26 FOODS, AND IS LOCATED IN A CASINO OR A CASINO ENTERPRISE.

27 (B) ANY OTHER BUSINESS ESTABLISHMENT THAT OFFERS GAMING THAT

1 IS INCIDENTAL TO THE PRINCIPAL PURPOSE OF THAT ESTABLISHMENT.
