

HOUSE BILL No. 5595

May 21, 2014, Introduced by Reps. Howrylak, Daley, McMillin, Goike, Leonard, Genetski, McBroom, Johnson, Kelly, Franz, Somerville, Kesto, Callton, Yonker, Bumstead and Rendon and referred to the Committee on Transportation and Infrastructure.

A bill to amend 1984 PA 431, entitled "The management and budget act," by amending section 298c (MCL 18.1298c), as added by 1988 PA 306.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 298c. The Michigan capitol park commission shall do all
2 of the following:

3 (a) Develop a master plan for, and manage the development and
4 operation of, the Michigan capitol park.

5 (b) Promulgate rules pursuant to the administrative procedures
6 act of 1969, ~~Act No. 306 of the Public Acts of 1969, being sections~~
7 ~~24.201 to 24.328 of the Michigan Compiled Laws 1969 PA 306, MCL~~
8 **24.201 TO 24.328**, necessary to carry out its powers and duties
9 under this section.

10 (c) Be responsible for the operation of programs, exclusive of
11 physical building management and maintenance, within the

1 jurisdiction of the Michigan capitol park commission as determined
2 under section 298b.

3 (d) Act as an advisory body to the department regarding the
4 development and operation of real property in Lansing not
5 designated as part of the Michigan capitol park under section 298b.

6 (e) Confer and cooperate with the Michigan capitol committee
7 in the execution of its duties under chapter 7 of the legislative
8 council act, ~~Act No. 268 of the Public Acts of 1986, being sections~~
9 ~~4.1701 to 4.1702 of the Michigan Compiled Laws 1986 PA 268, MCL~~
10 **4.1701 TO 4.1702.**

11 (f) Coordinate with the city of Lansing any state activities
12 or developments in and around the Michigan capitol park.

13 (g) Advise the department of state police regarding the
14 provision of police and security services for the Michigan capitol
15 park, and the enforcement of rules for the care and preservation of
16 the Michigan capitol park.

17 **(H) WHEN SUFFICIENT MONEY IS RECEIVED TO MEET THE COSTS OF**
18 **PLACEMENT, PROVIDE FOR THE APPROPRIATE DISPLAY OF THE PLAQUE**
19 **DONATED BY BRASS ROOTS AND HONORING THE RIGHT TO BEAR ARMS UNDER**
20 **AMENDMENT II OF THE CONSTITUTION OF THE UNITED STATES AND UNDER**
21 **SECTION 6 OF ARTICLE I OF THE STATE CONSTITUTION OF 1963.**

22 **(I) ~~(h)~~** Annually report to the governor and the legislature on
23 the activities of the Michigan capitol park commission. The report
24 shall review the progress of, and any changes in, the master plan
25 as well as the development and operation of the Michigan capitol
26 park.
